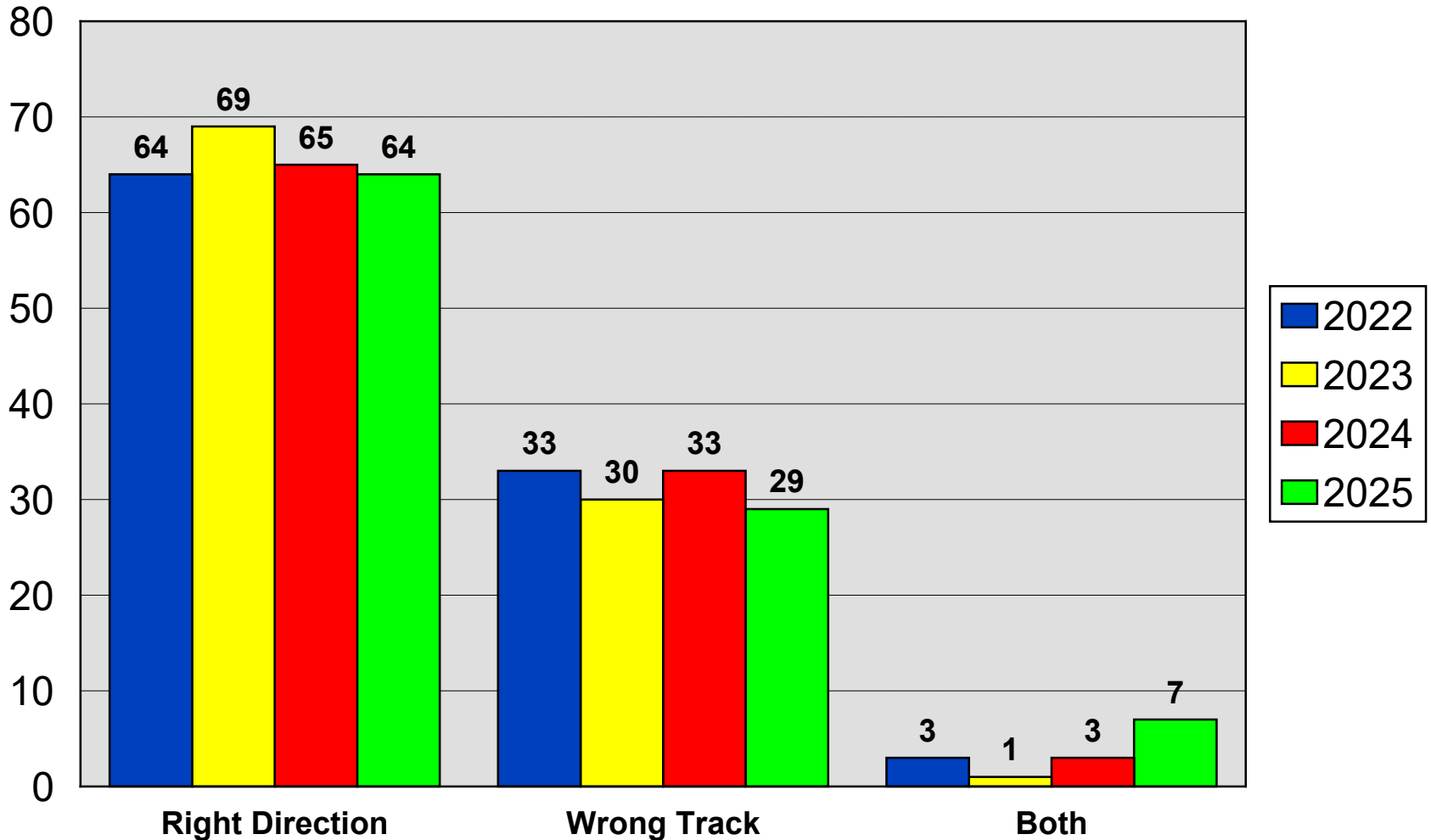
Survey Methodology

2025 August Statewide Survey

-) 800 random sample of Minnesota residents.
-) Results projectable within +/-3.5% in 95 out of 100 cases
-) Average interview time of 11 minutes
-) Non-response level of 6.5%
-) Telephone interviews conducted between August 18th and 27th, 2025
-) Cellphone Only Households: 61%
-) Landline Only Households: 10%
-) Both Landline and Cellphone Households: 29%

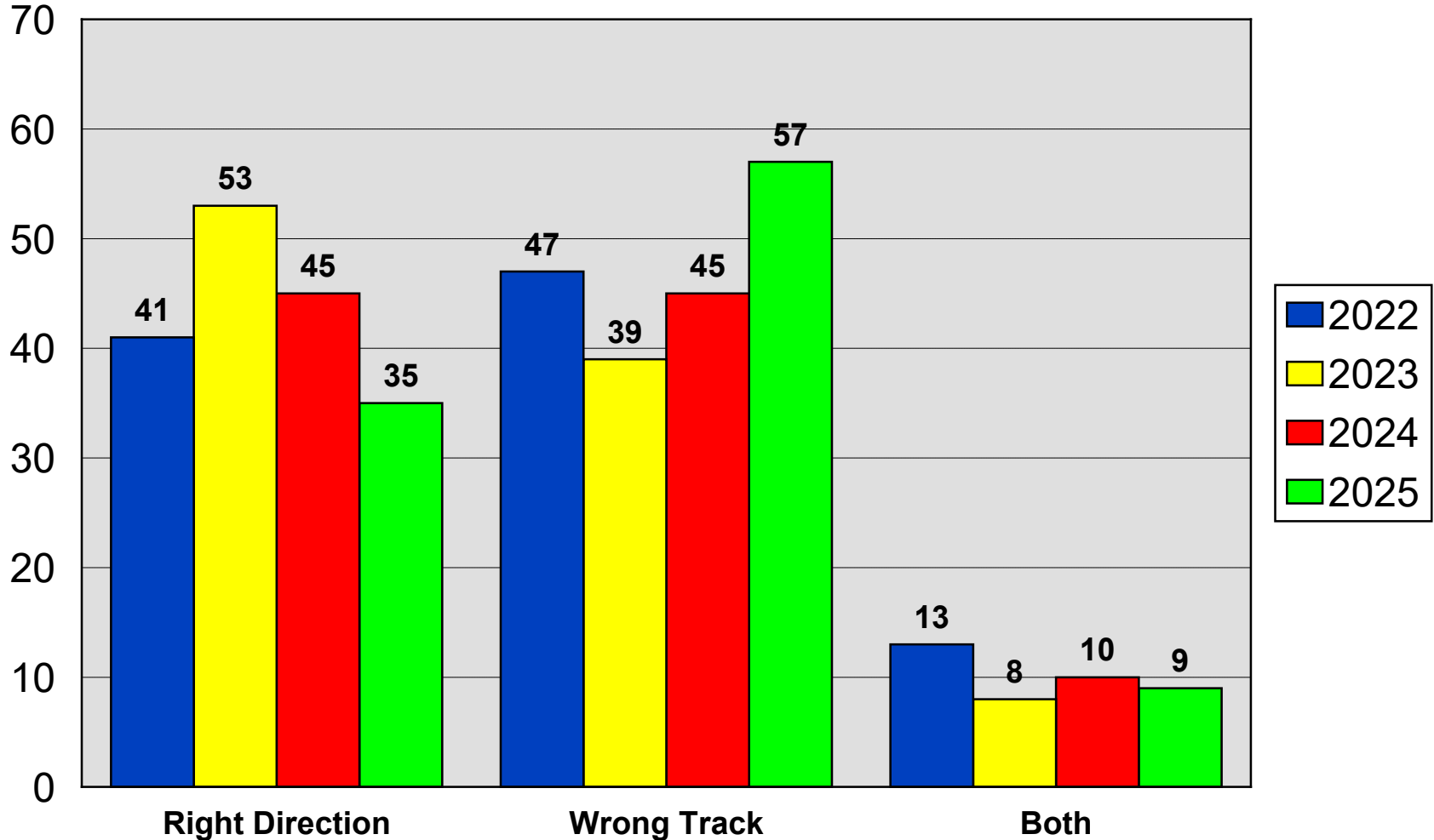
Direction of Minnesota

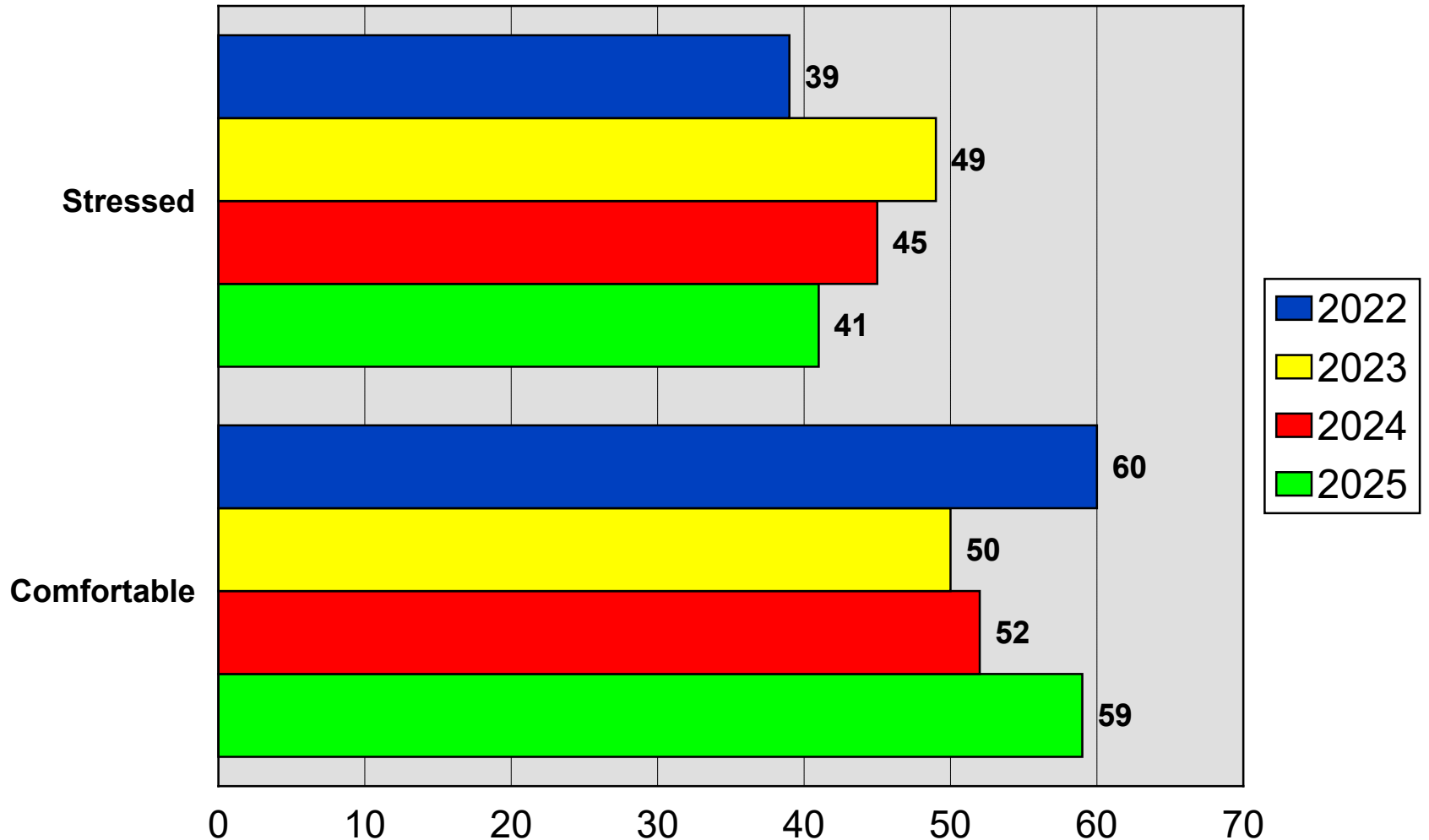
Direction of United States

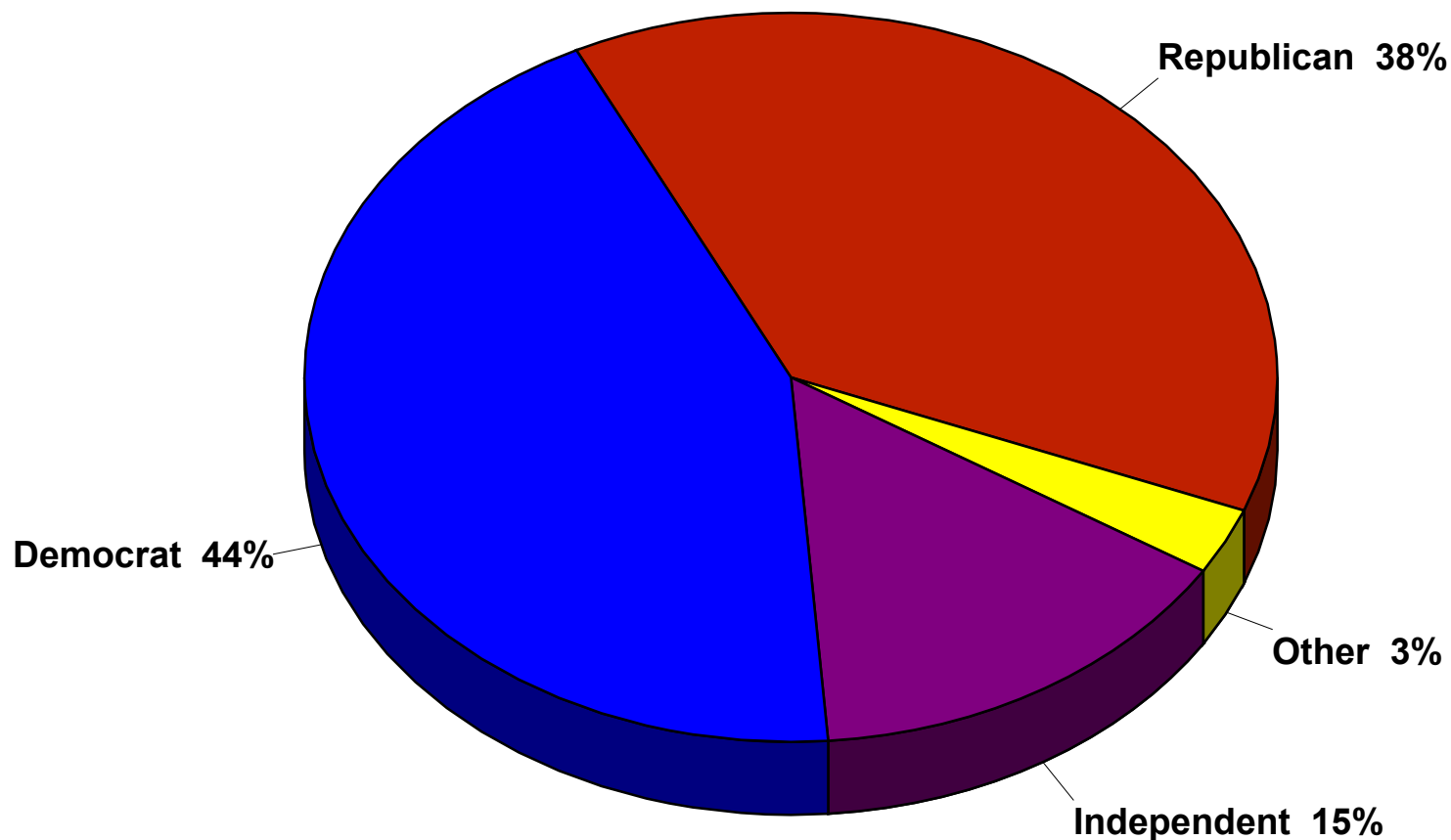

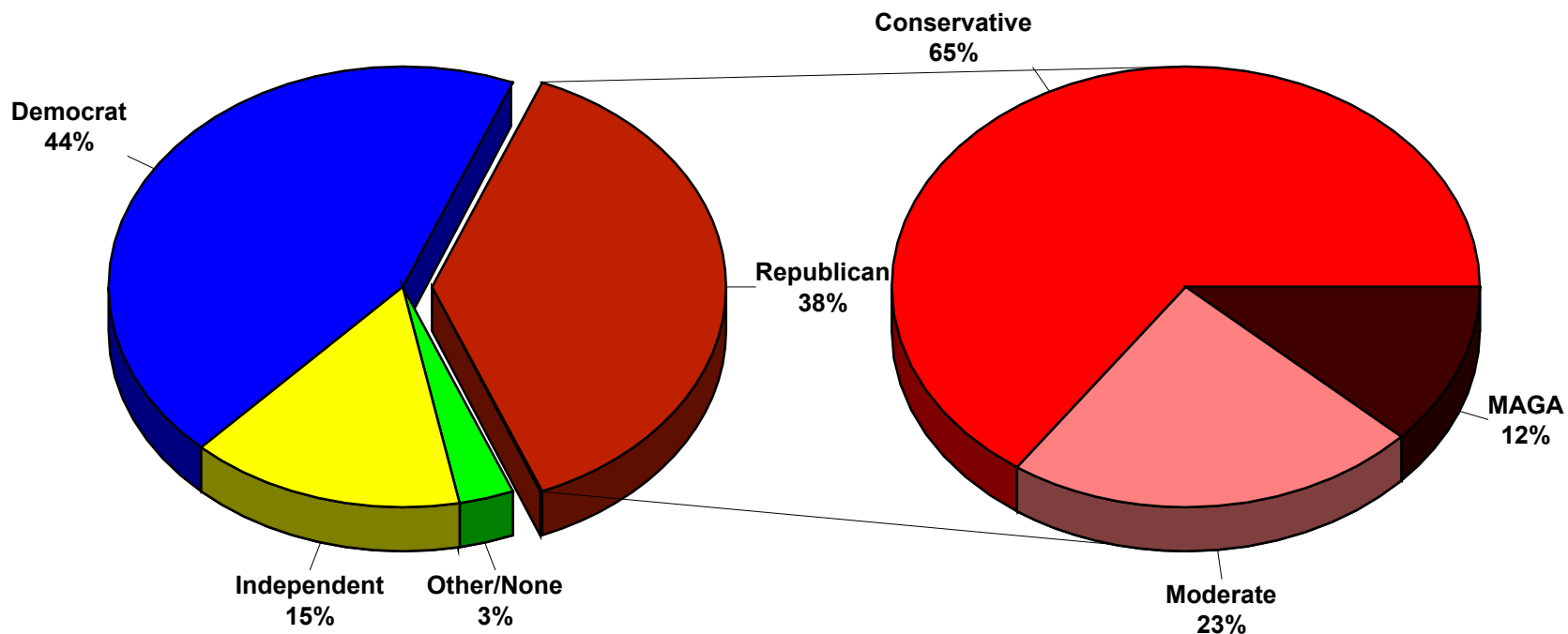

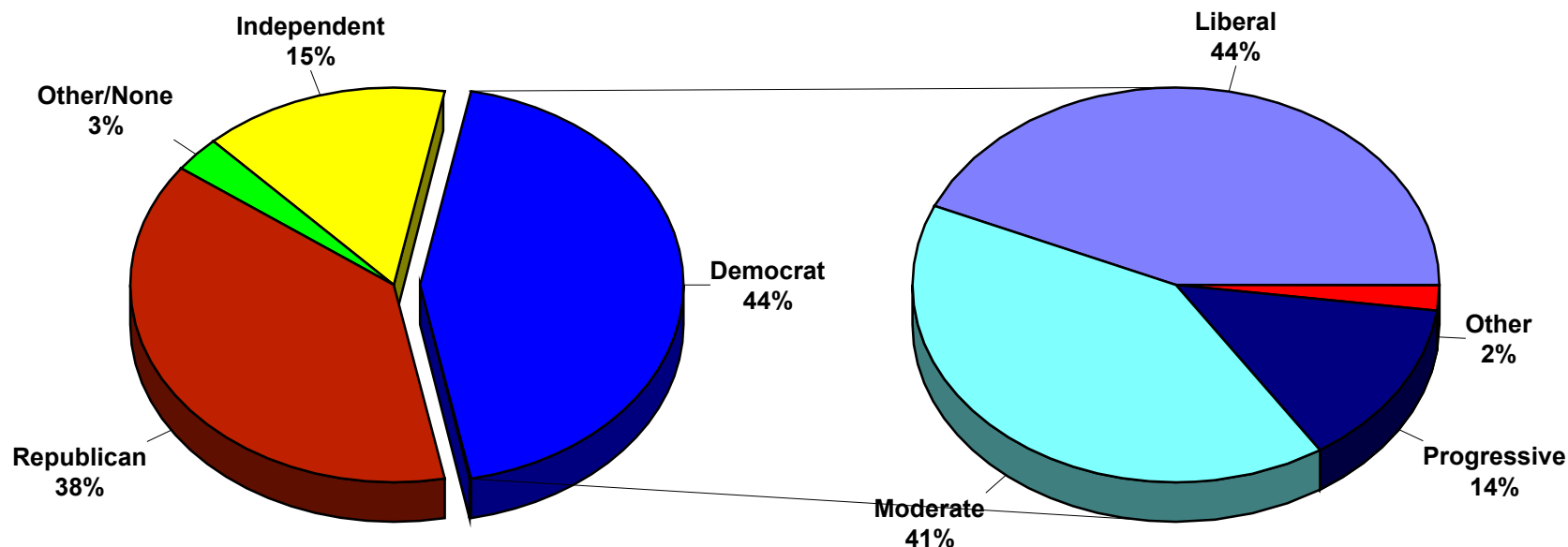
Republican Political Ideology

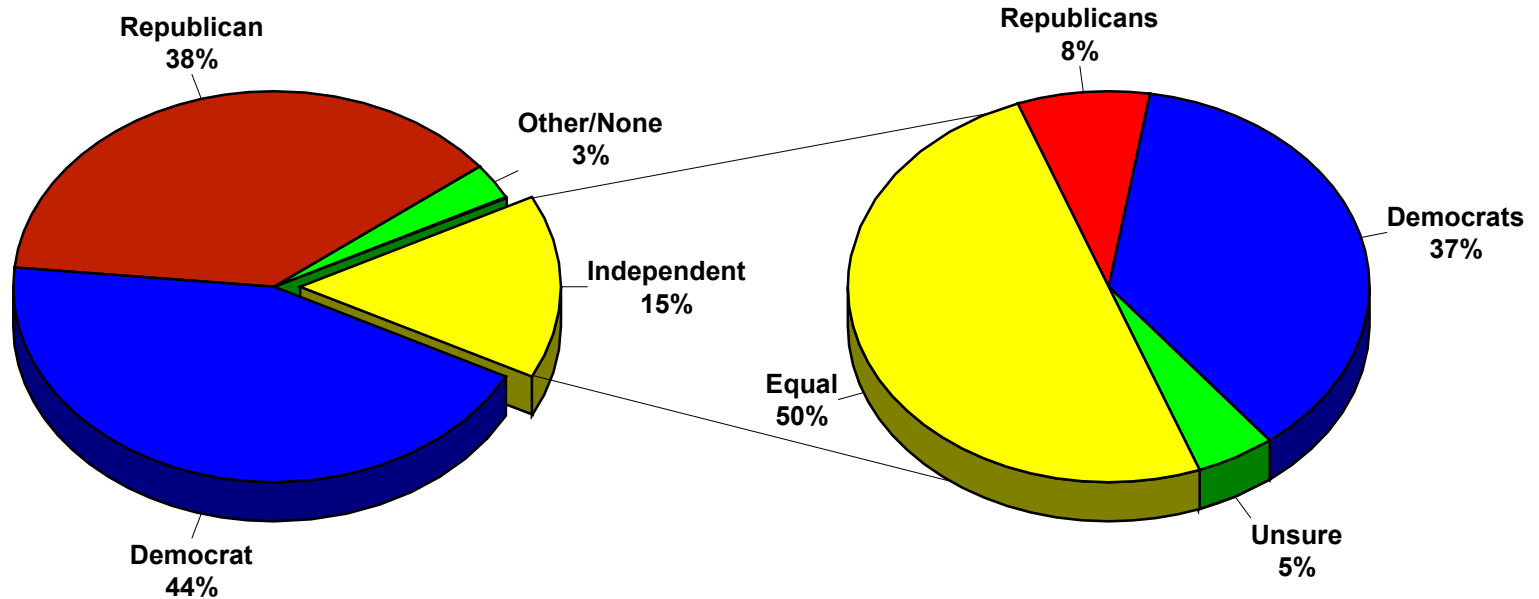
Democratic Political Ideology

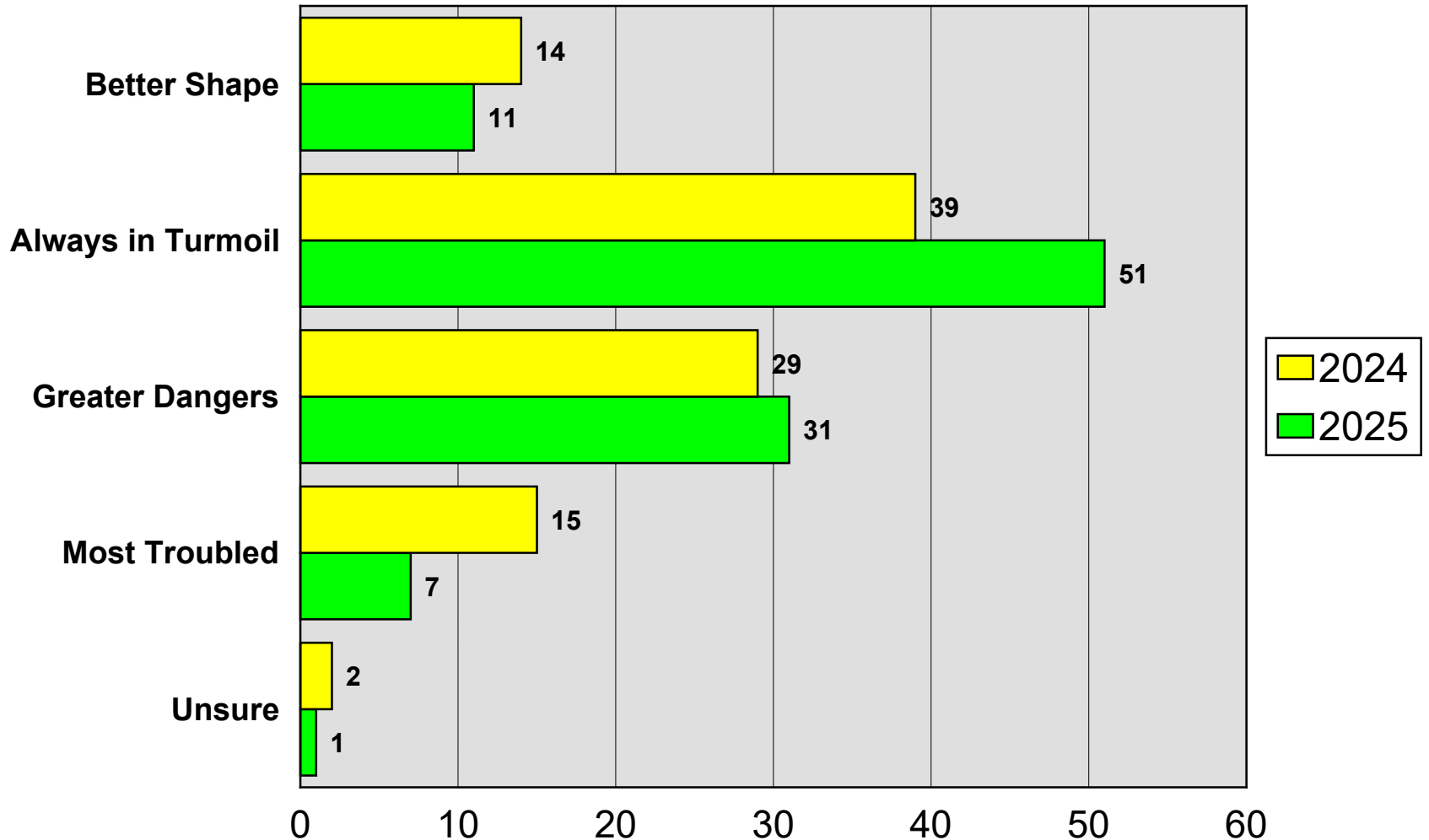

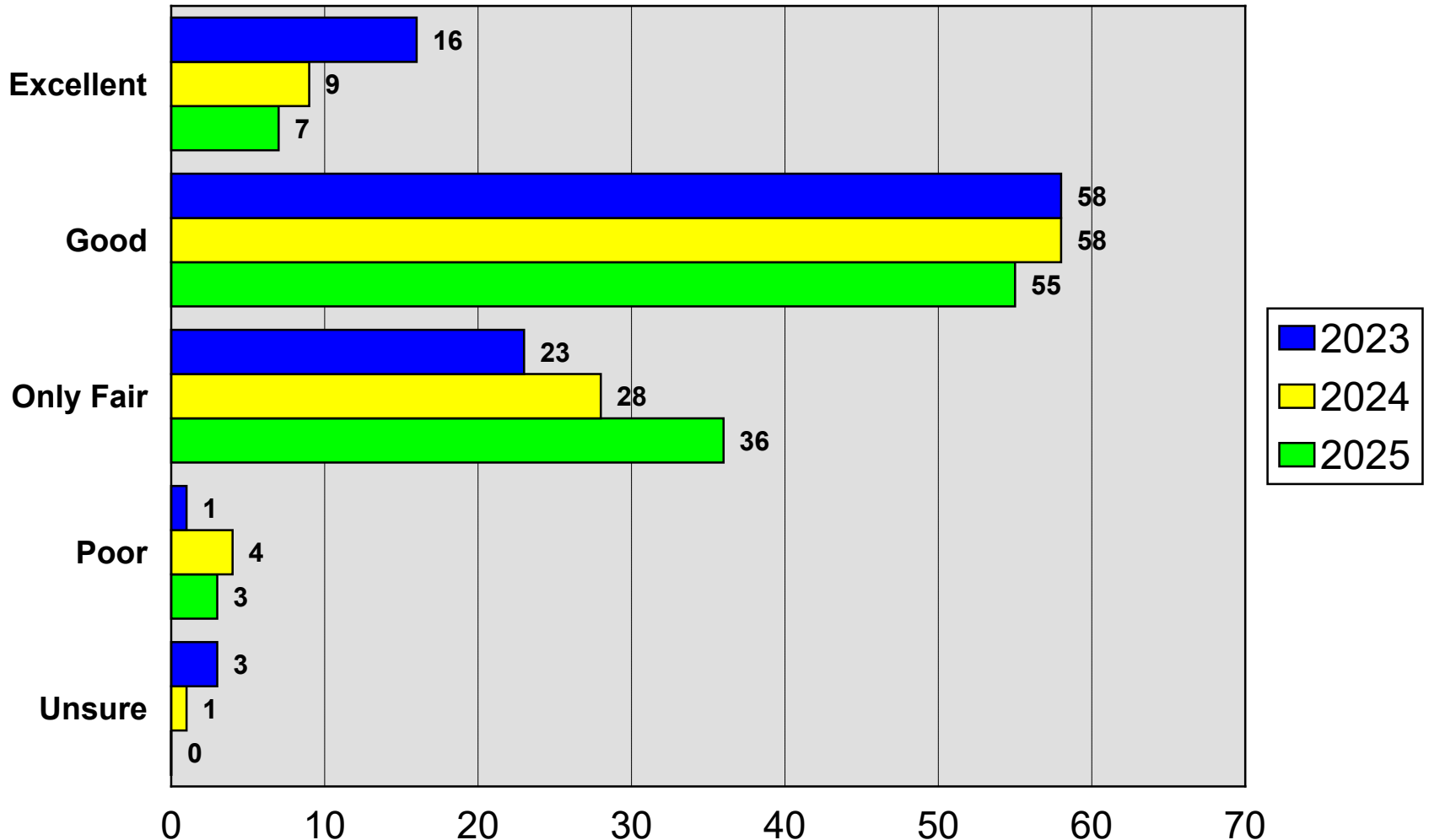

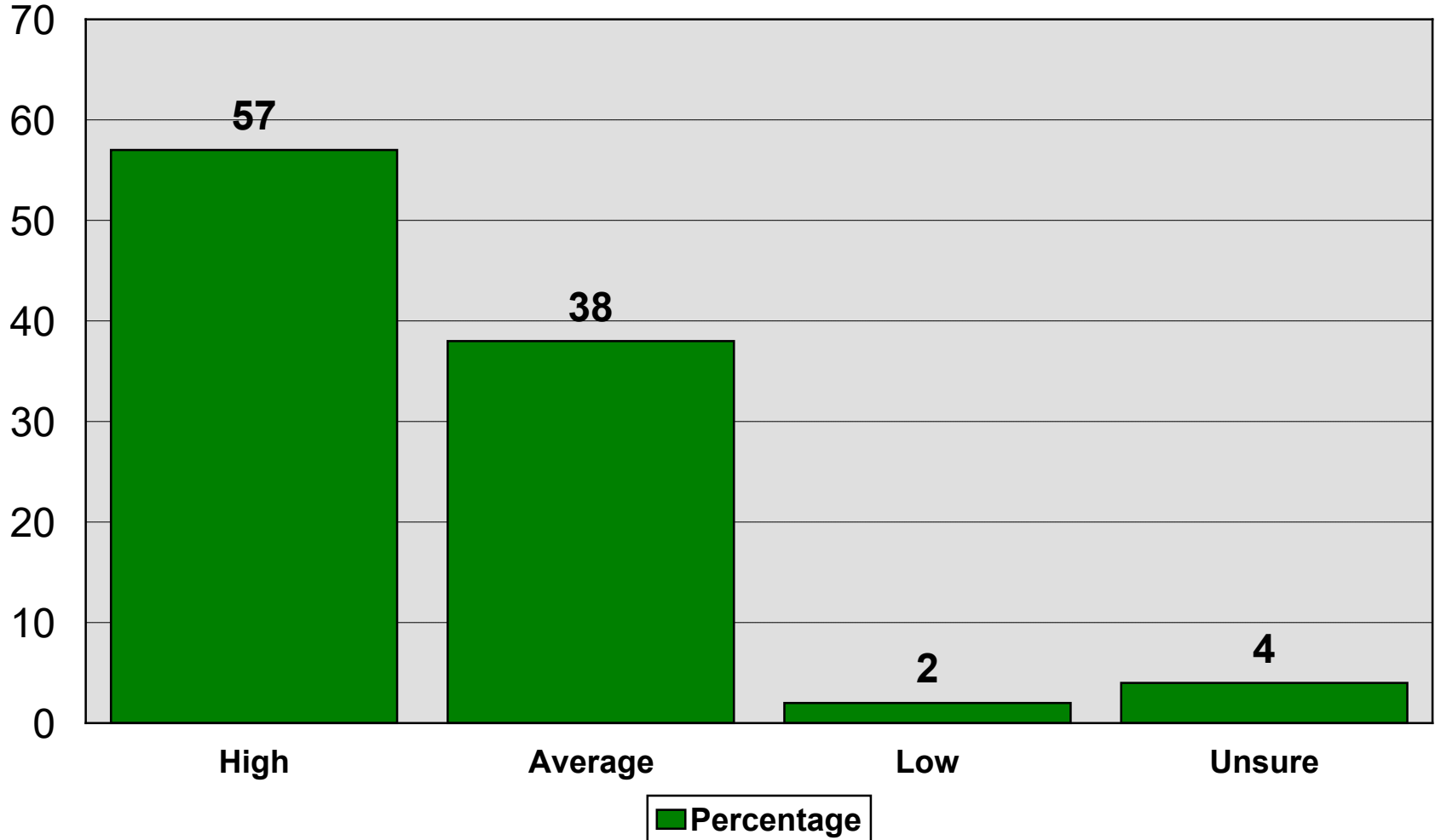
Value of Services for Taxes Paid

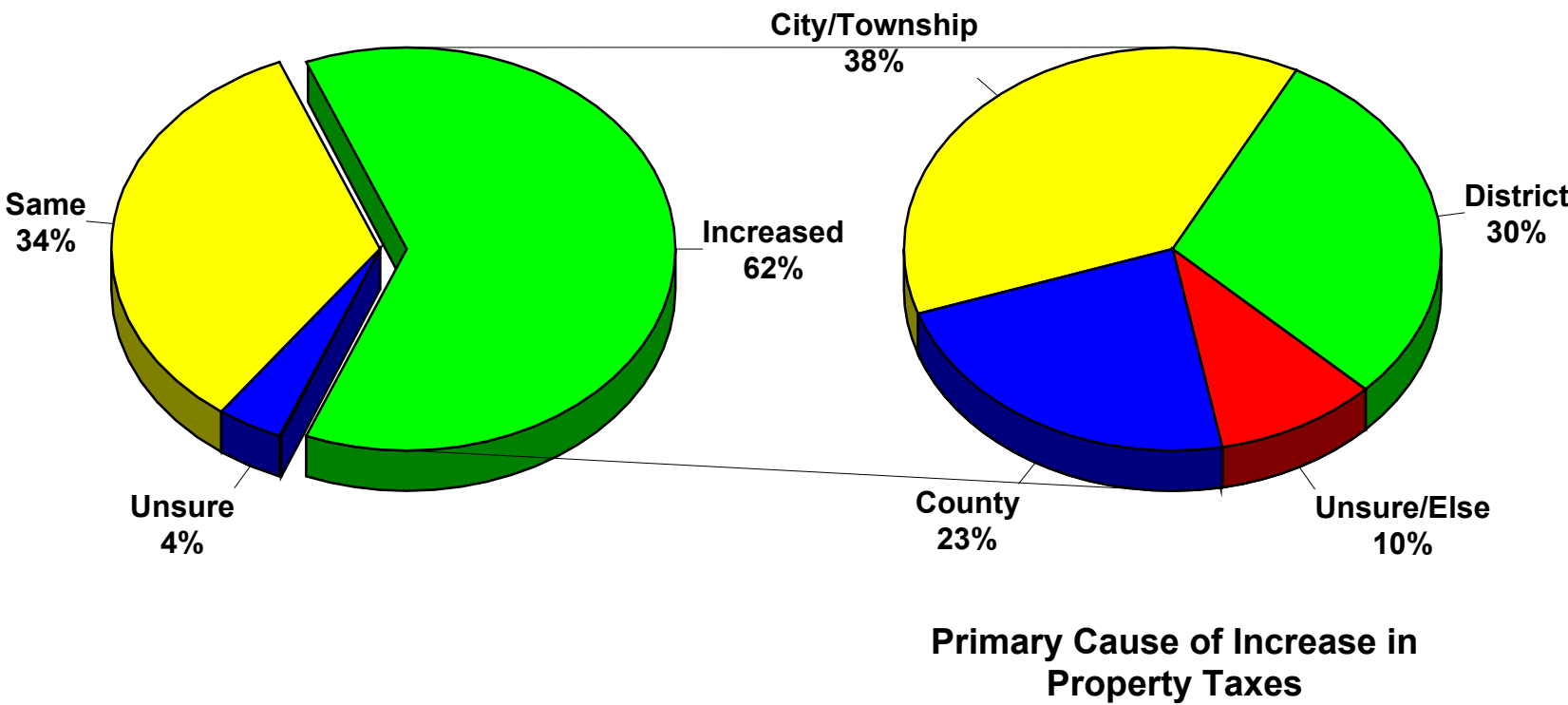
Perception of Property Taxes

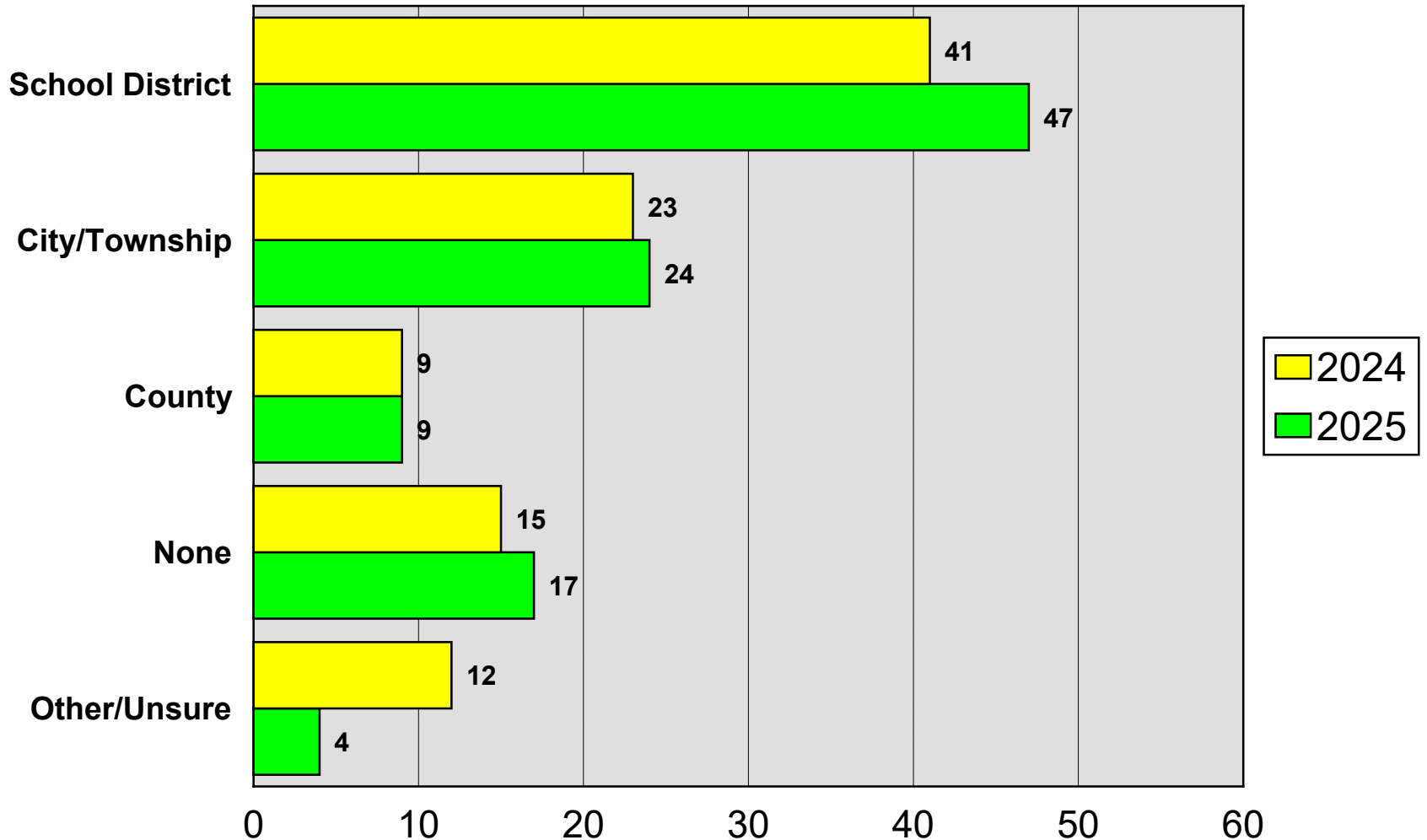
Property Taxes Over Past Couple of Years

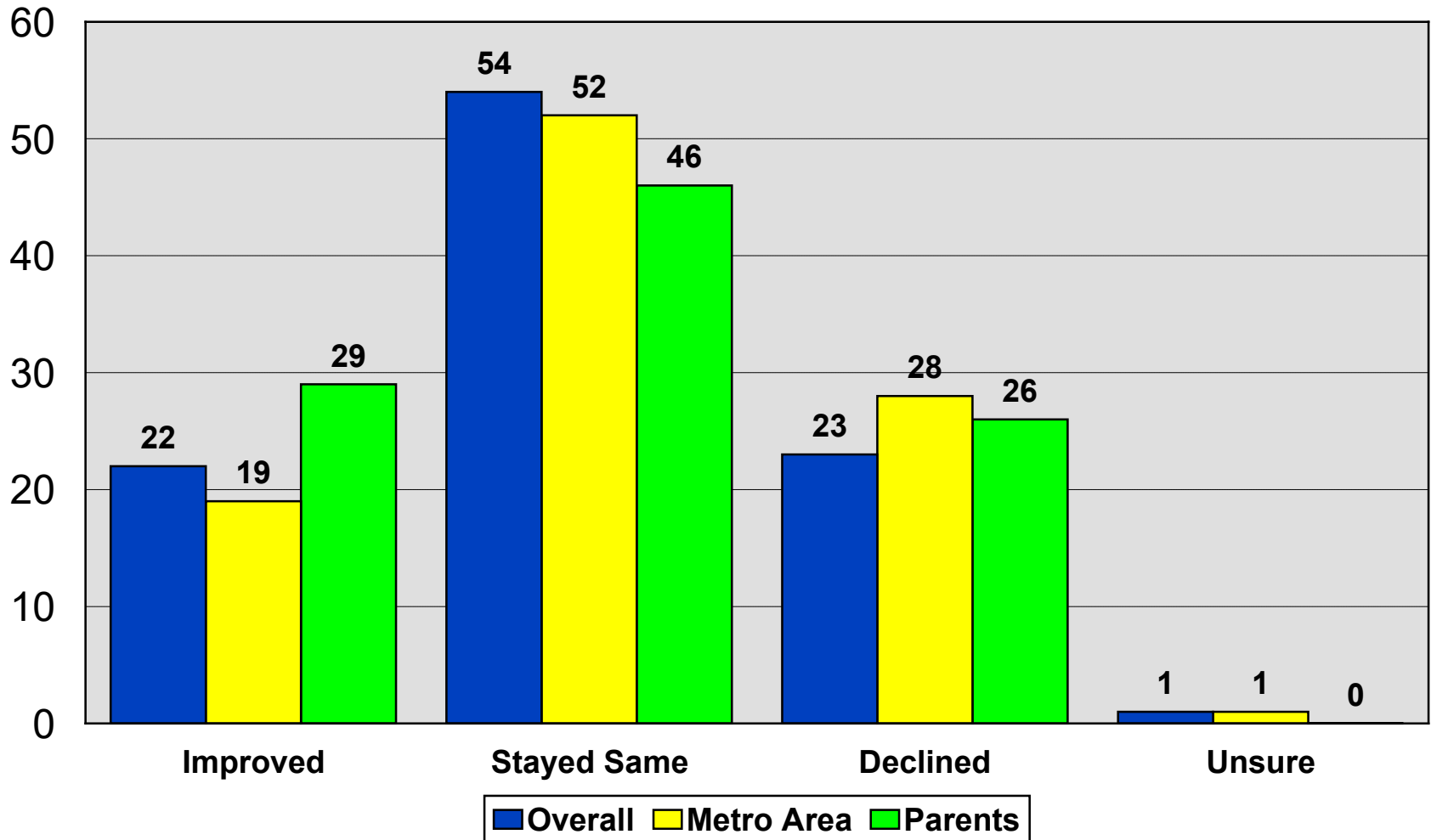

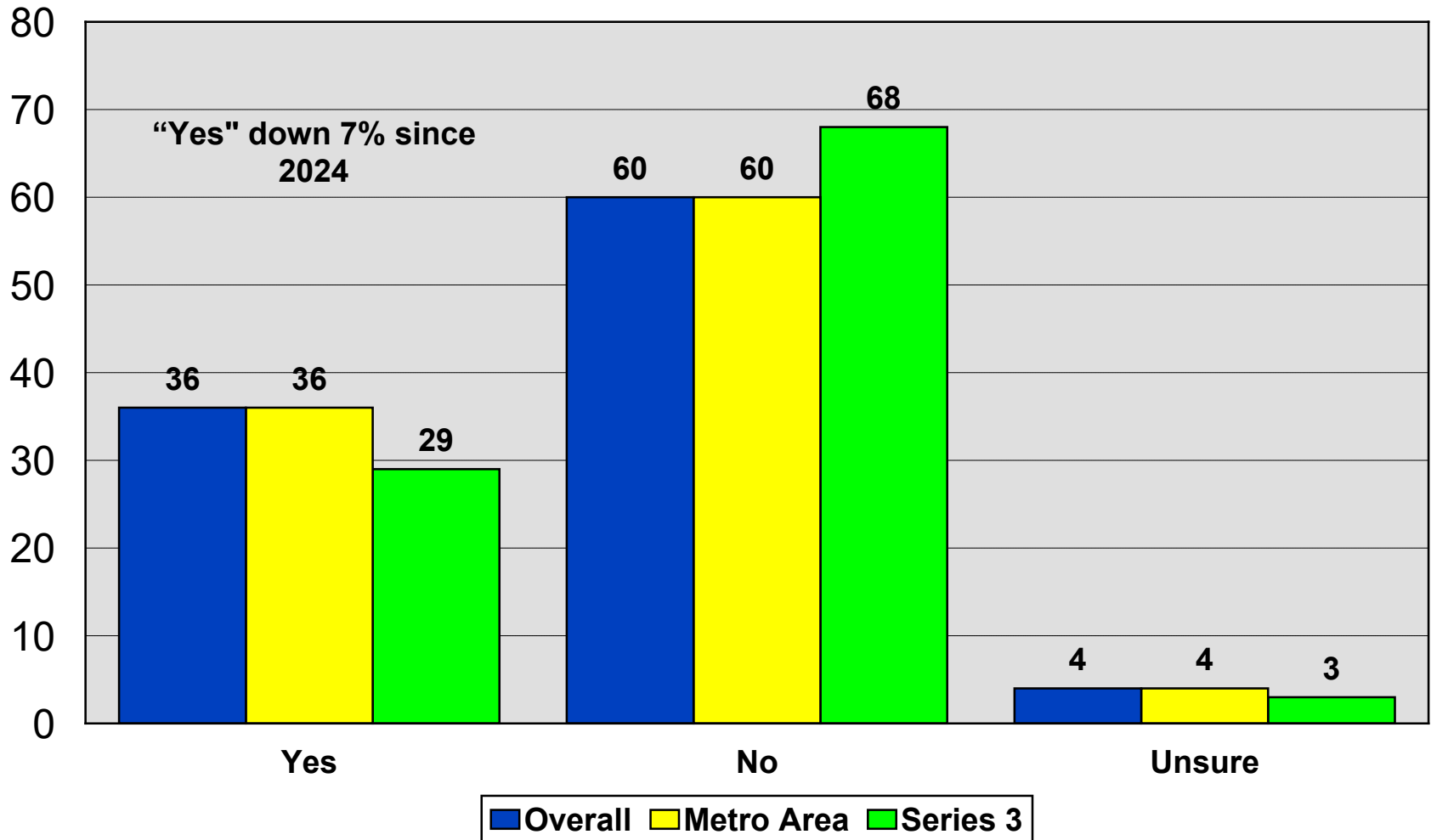
Quality of K-12 Education over past three years

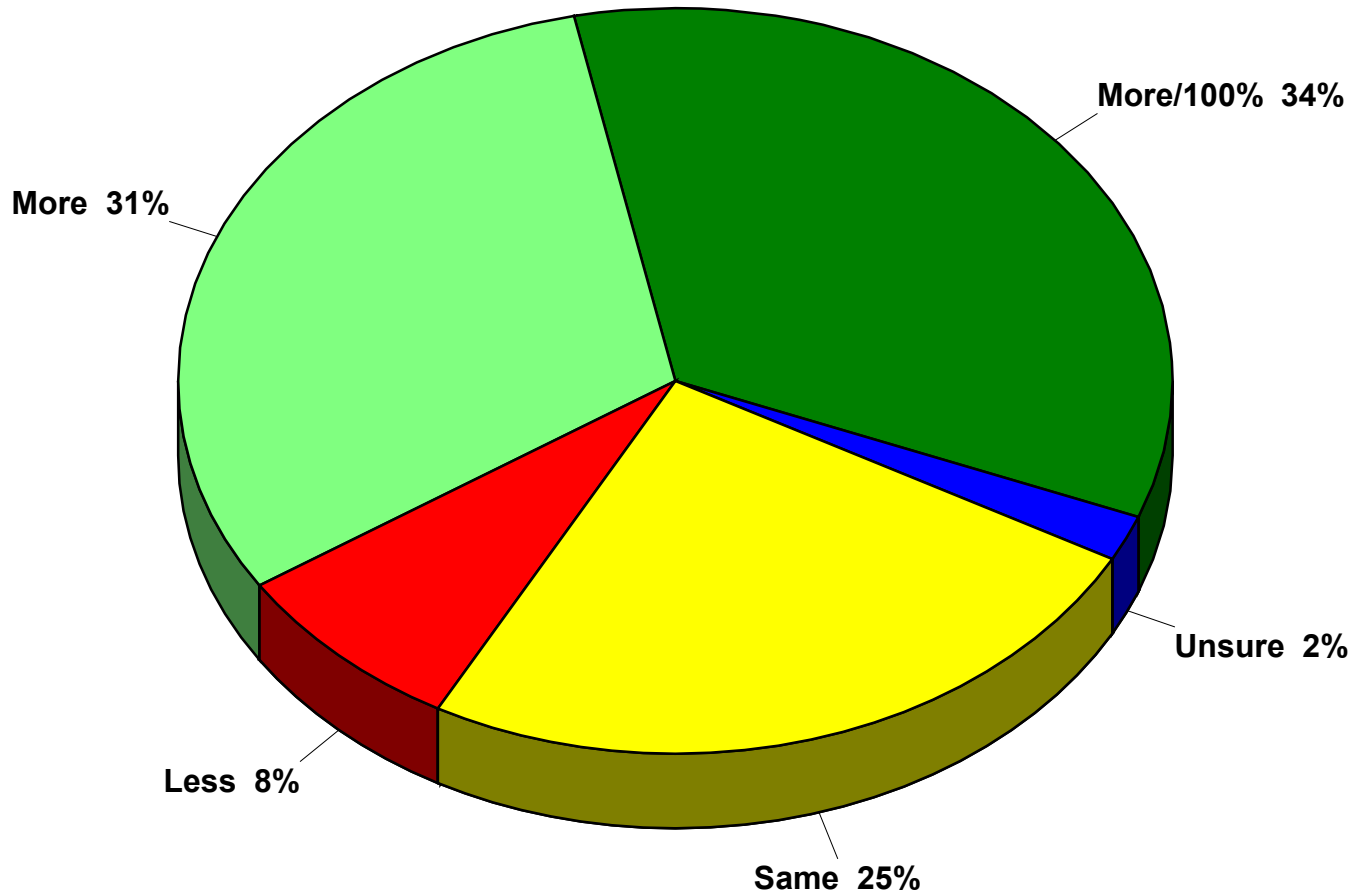
Adequacy of Funding of Local Schools

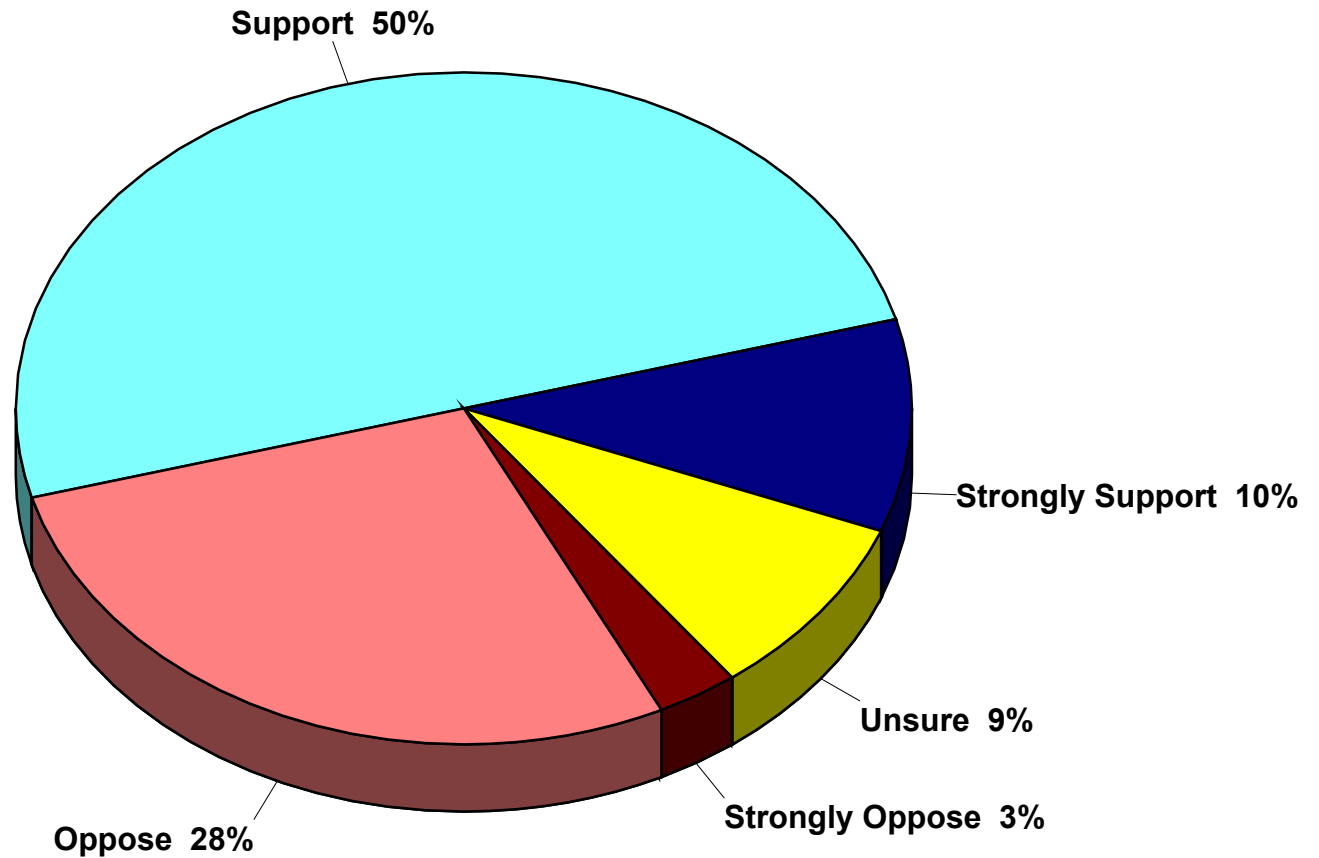
State of Minnesota K-12 Funding

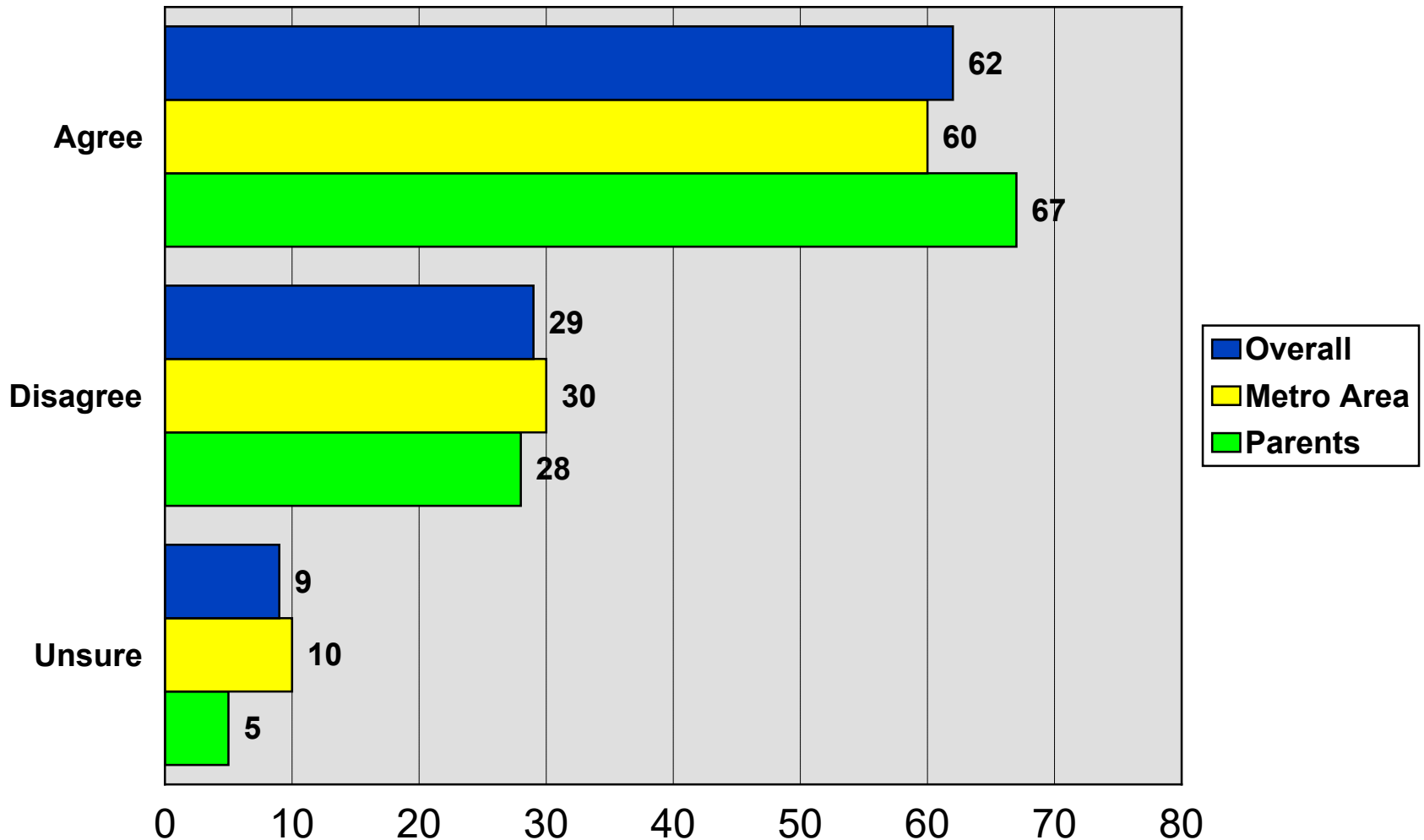

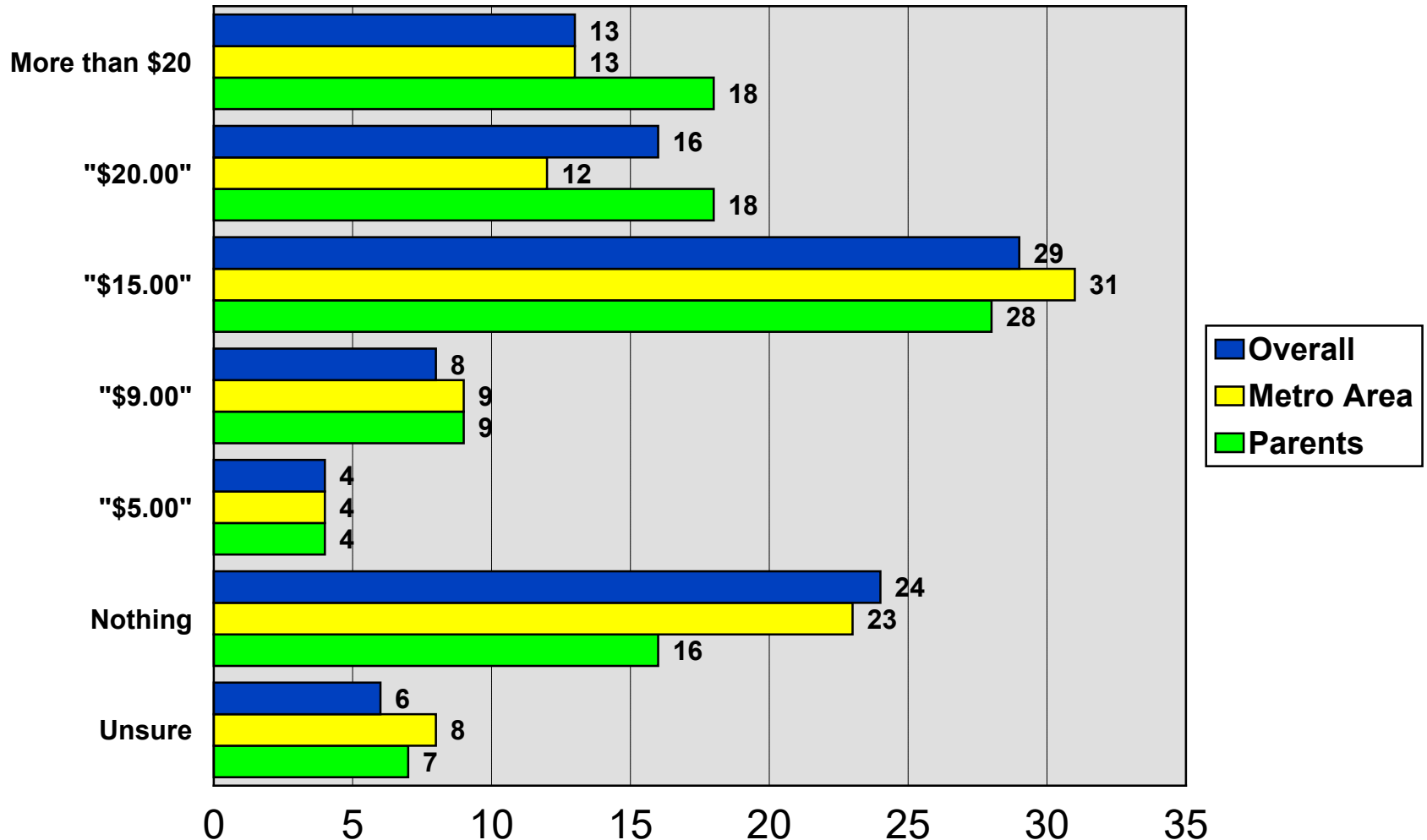

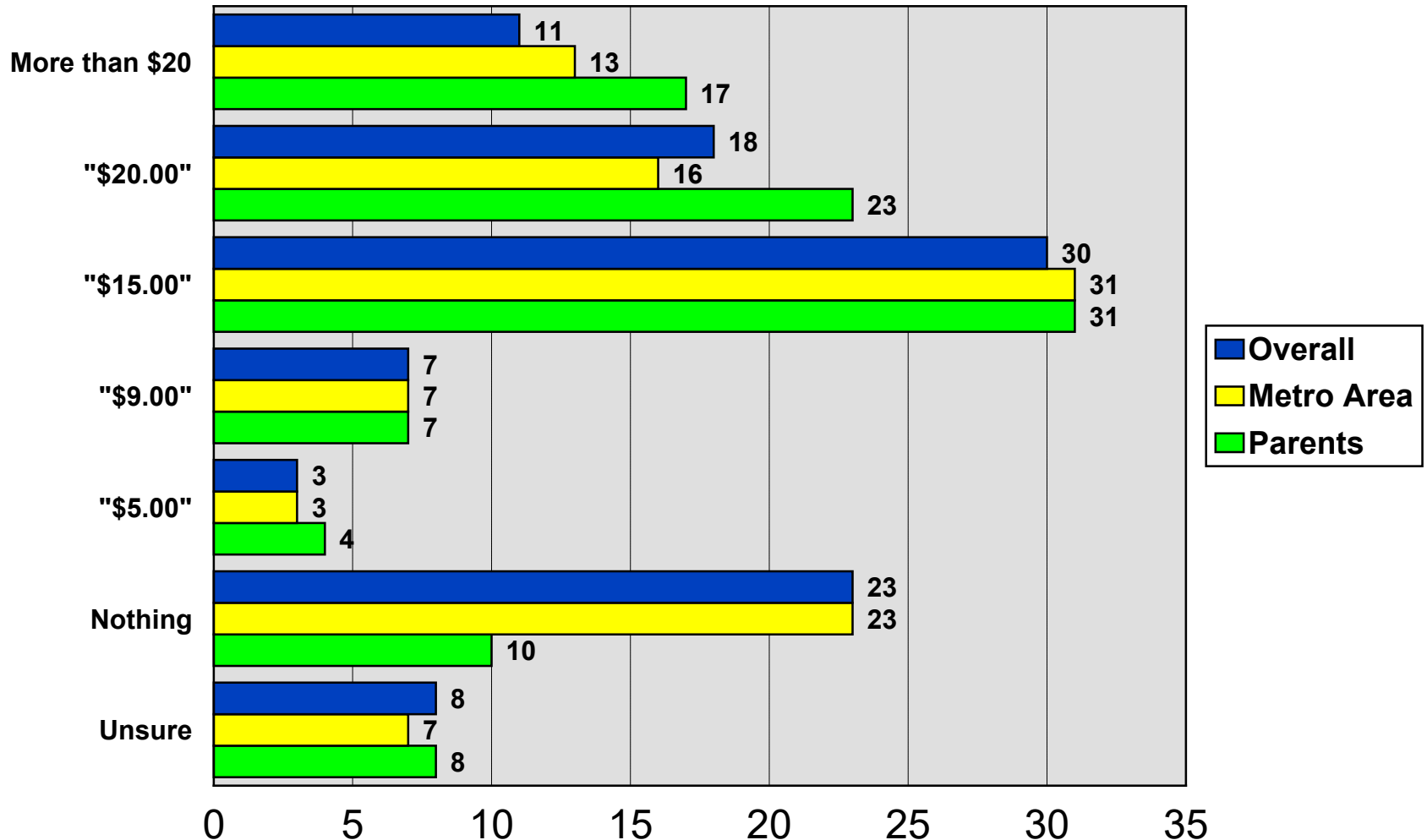

(Overall)

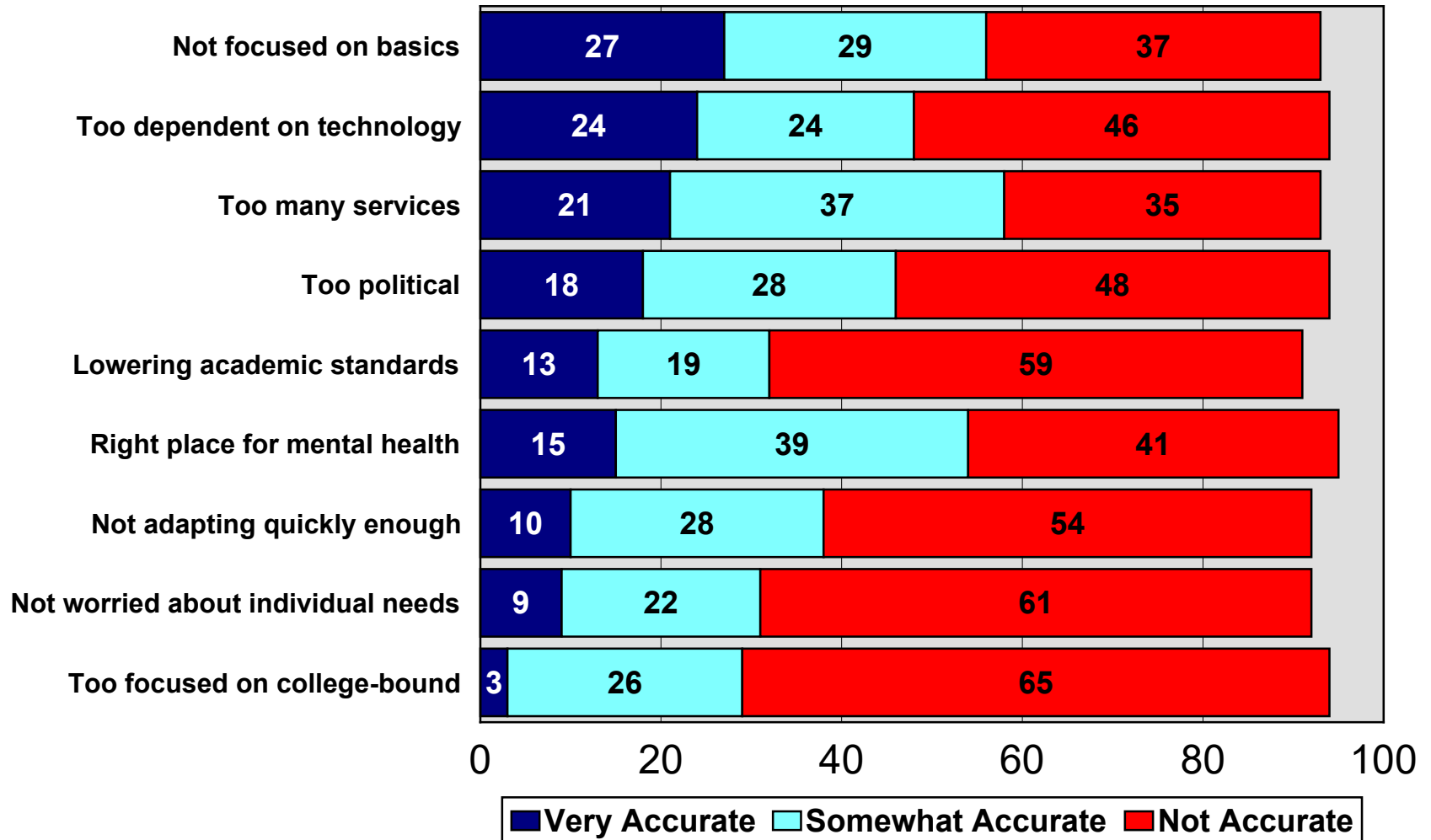

(Metro Area)

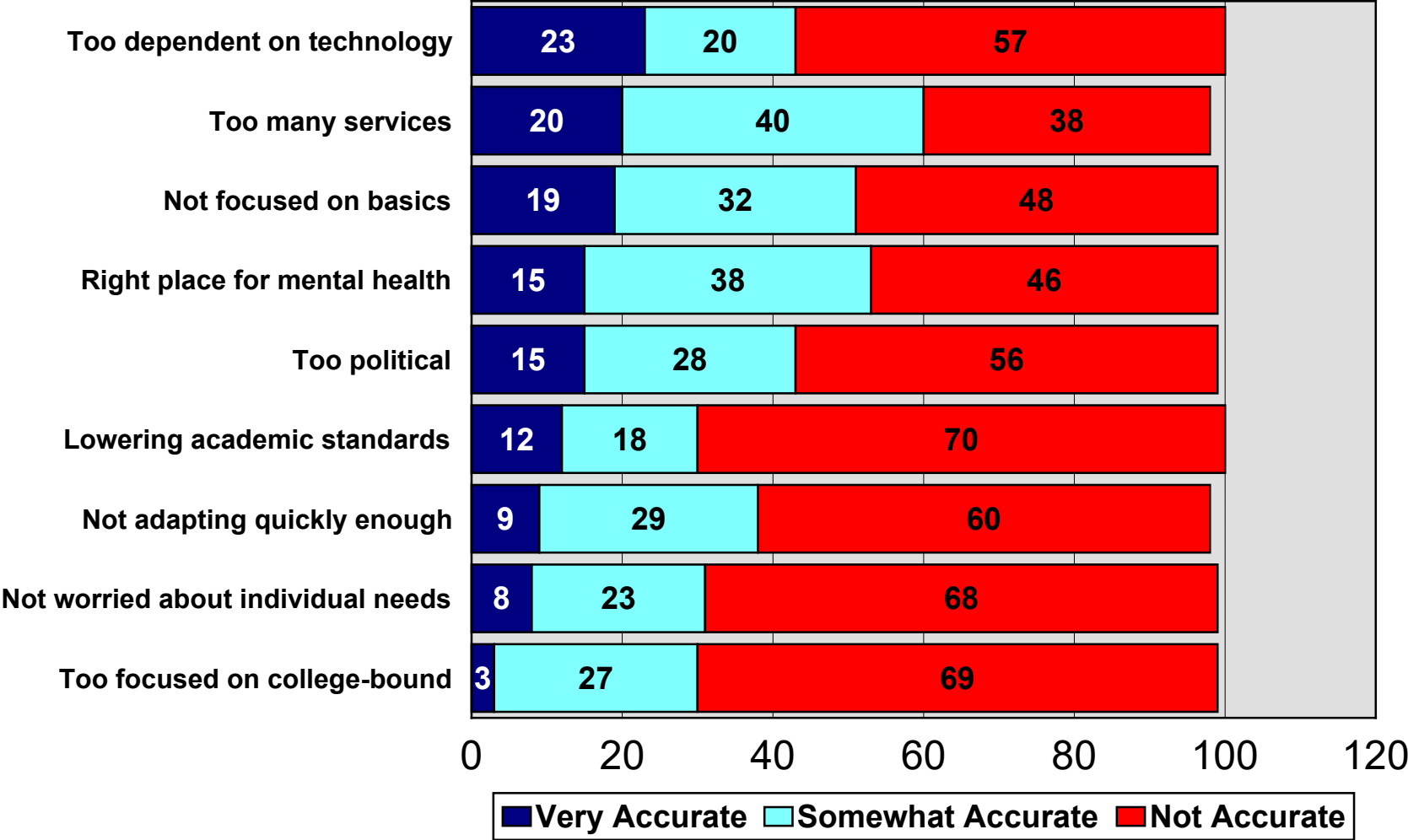

(Parents)

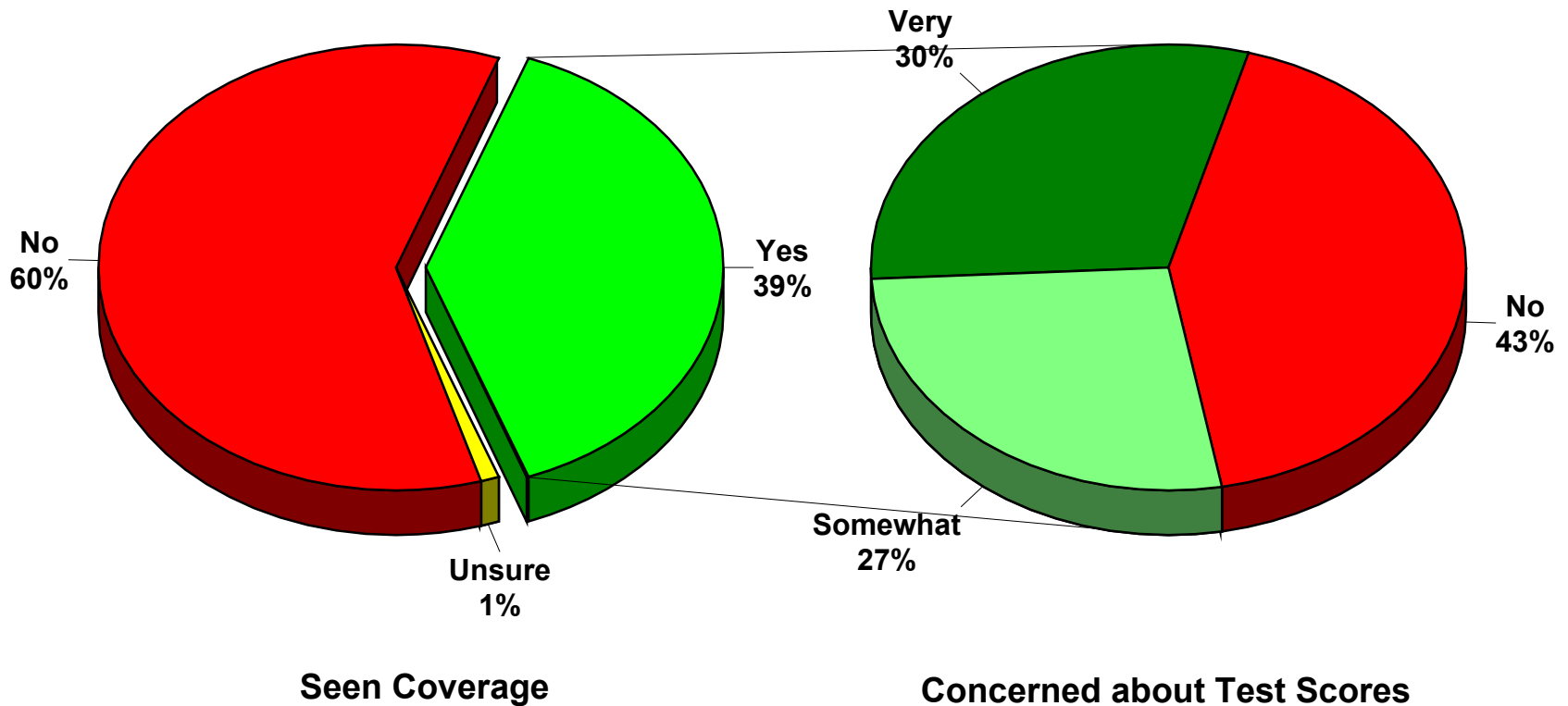

(Overall)

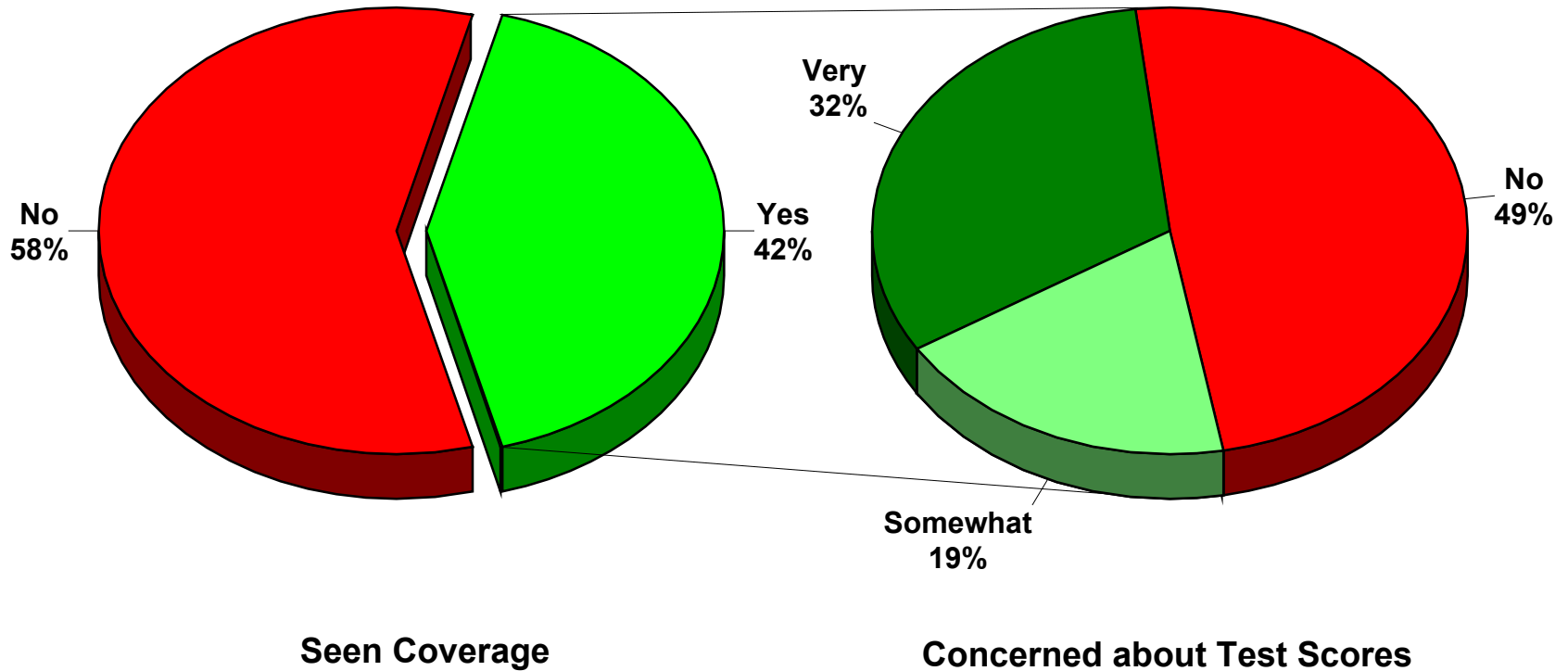

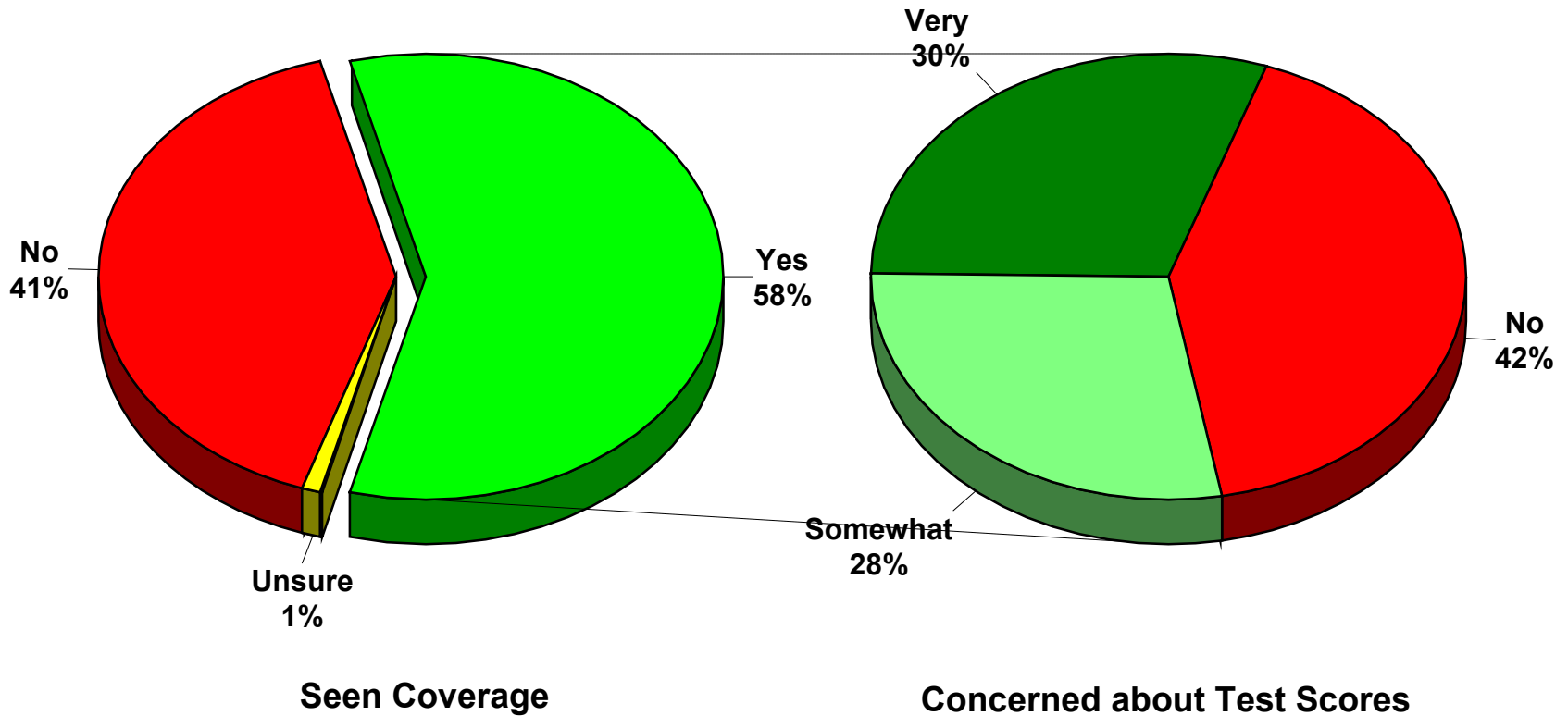

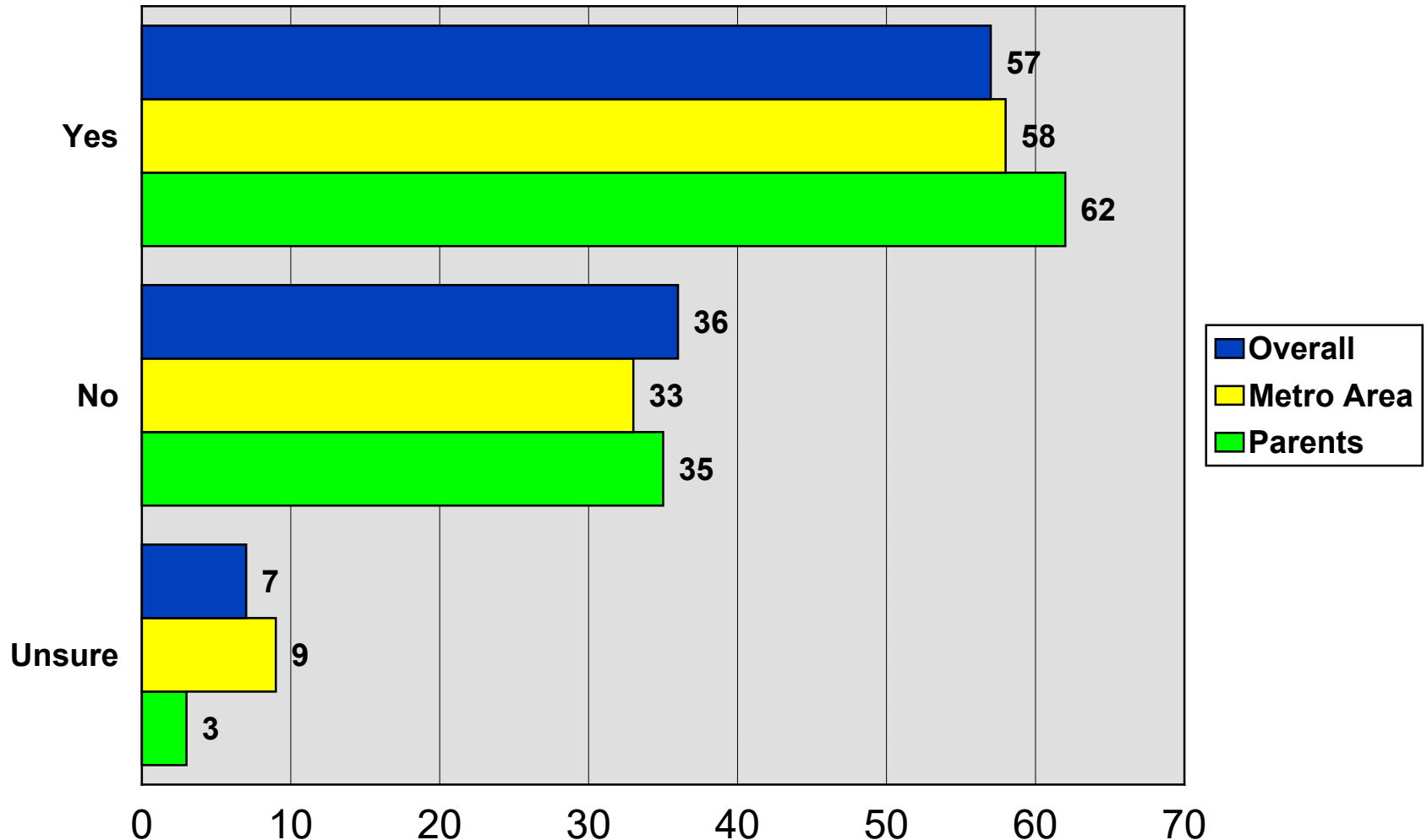

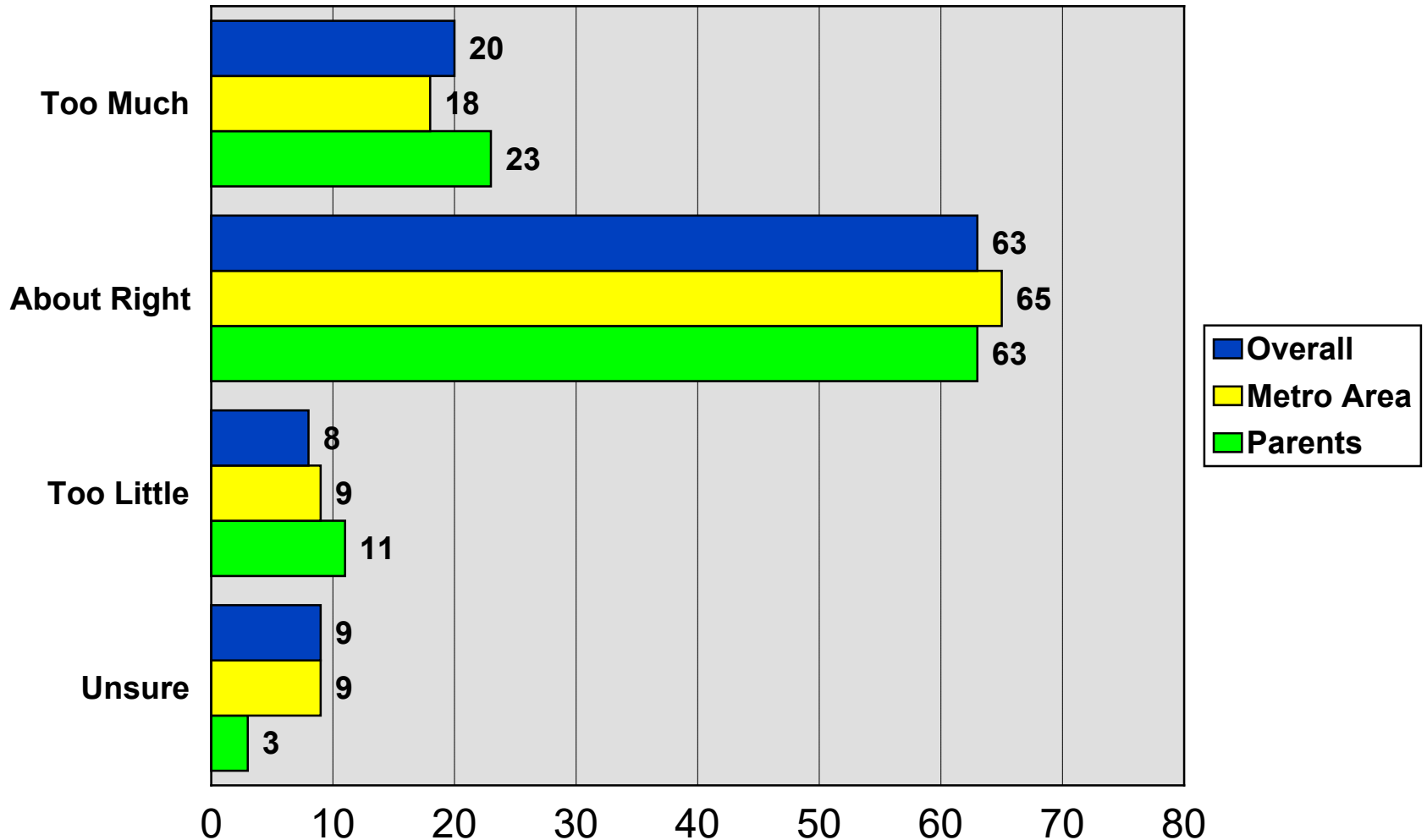

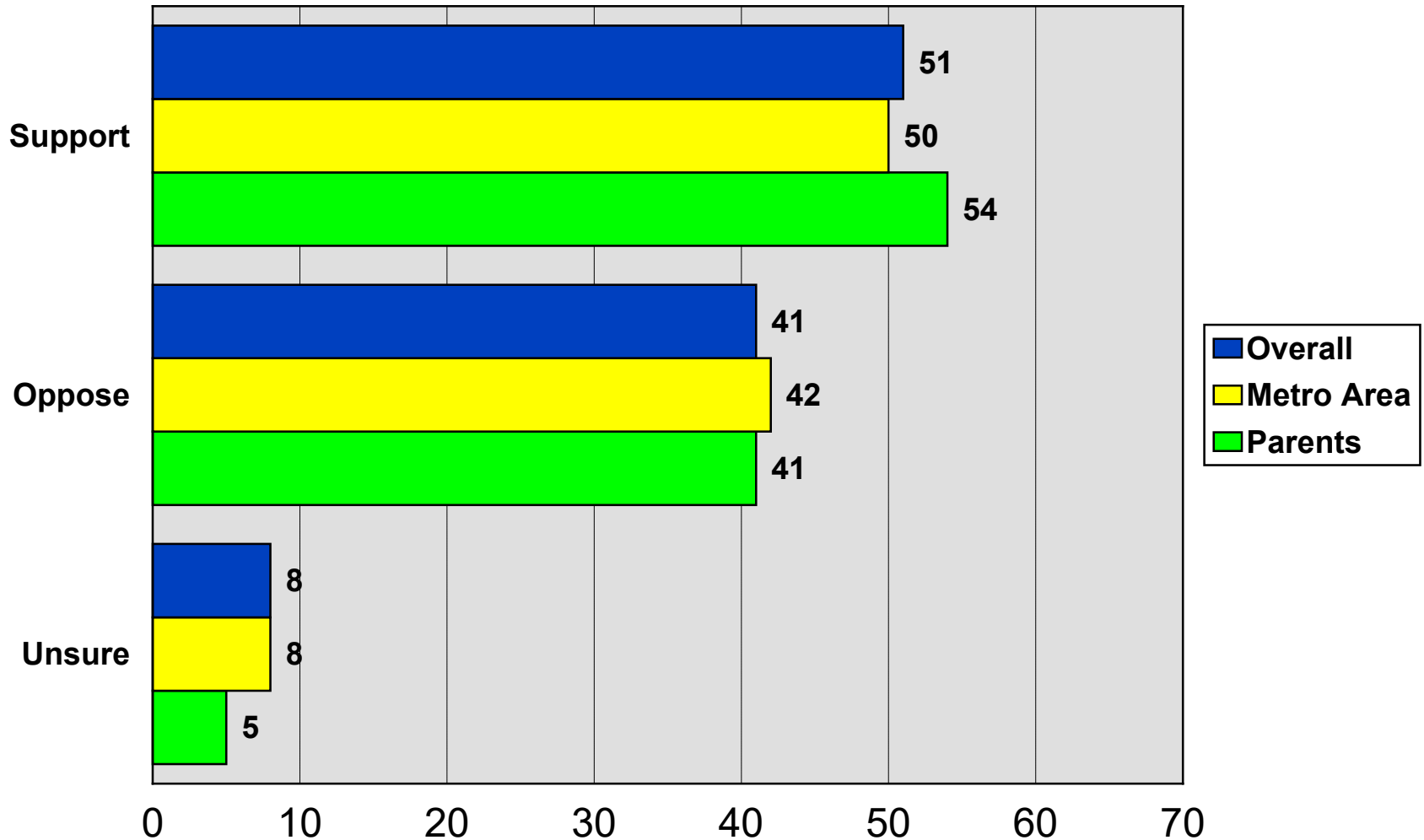
Amount of Testing

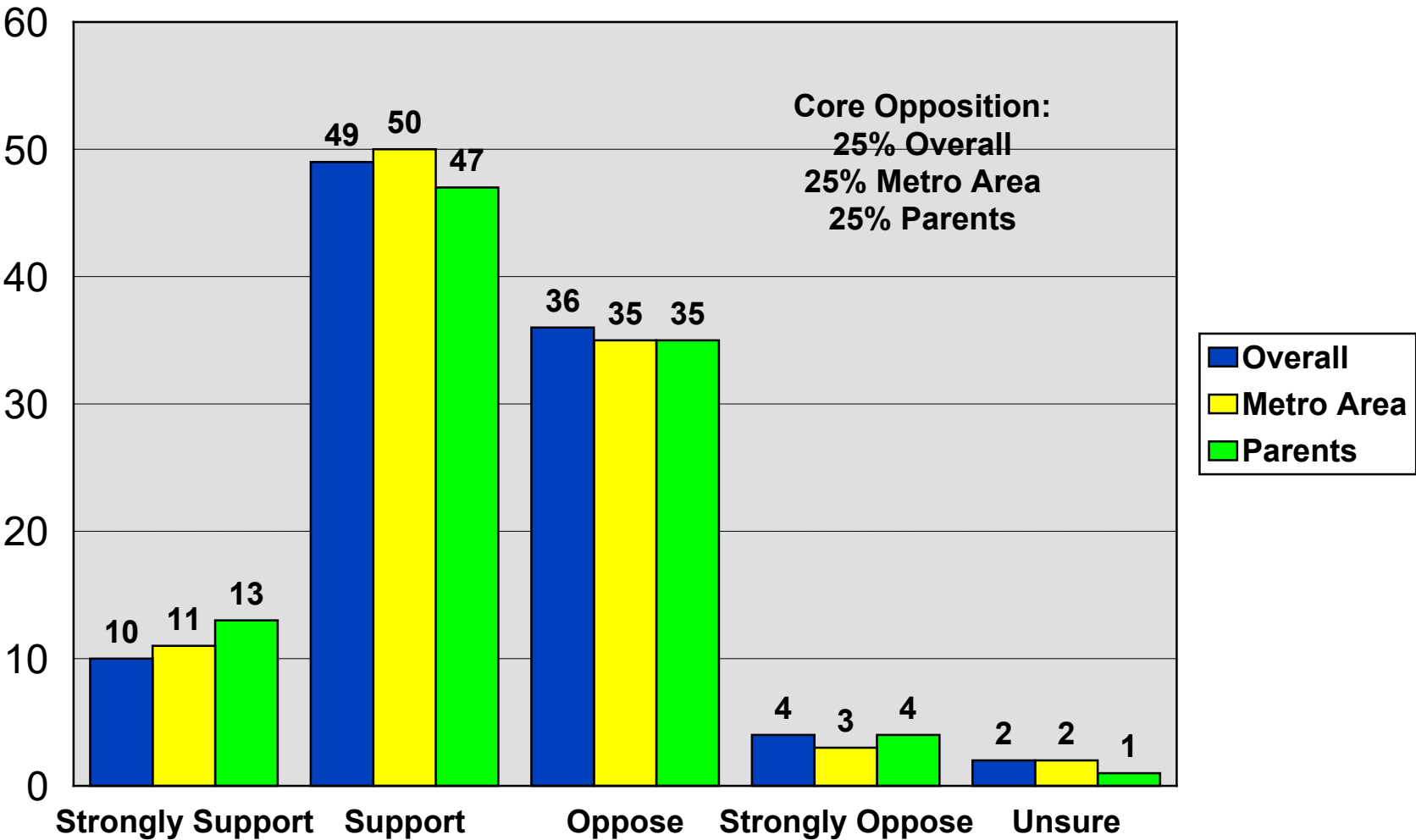

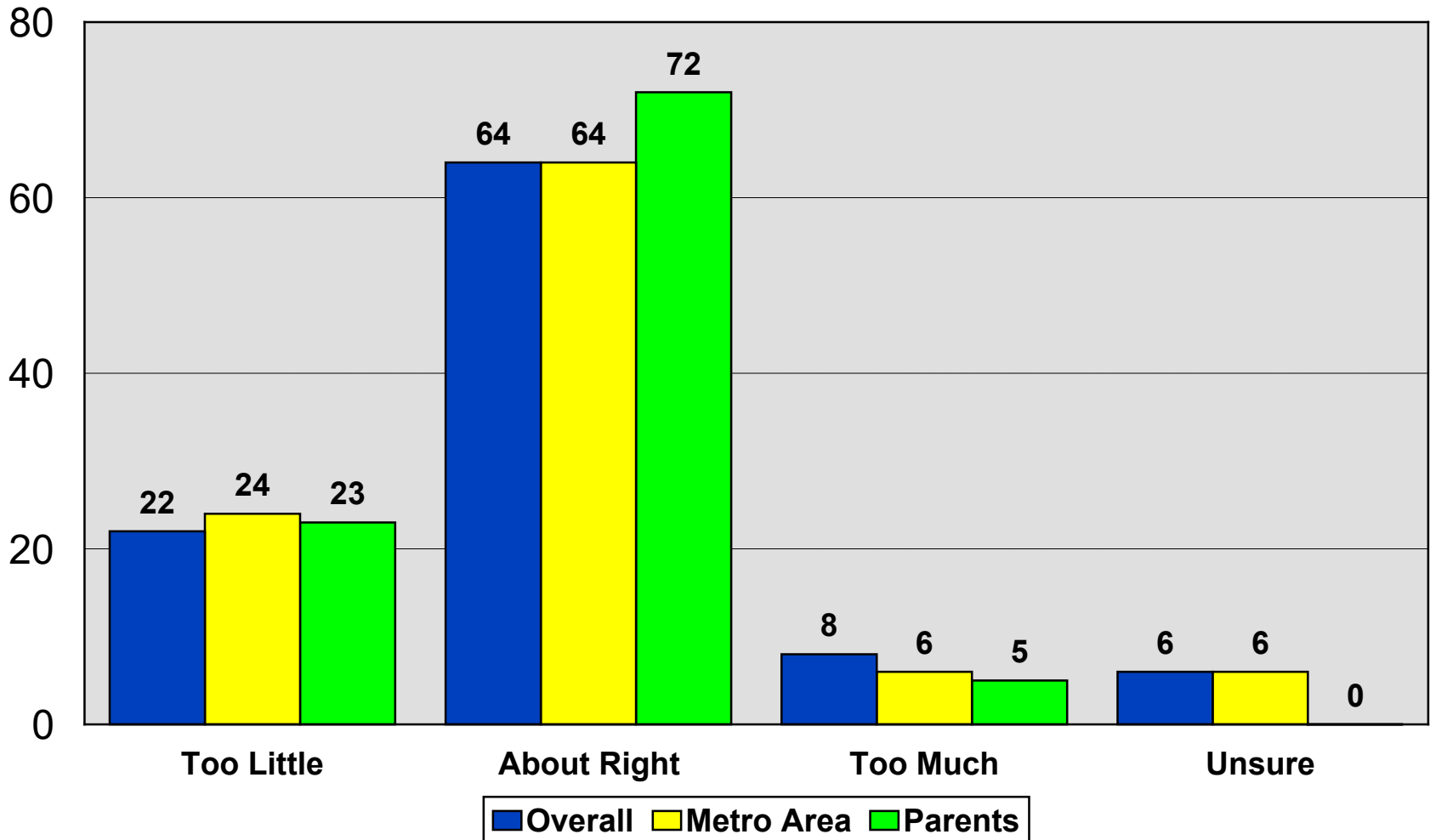

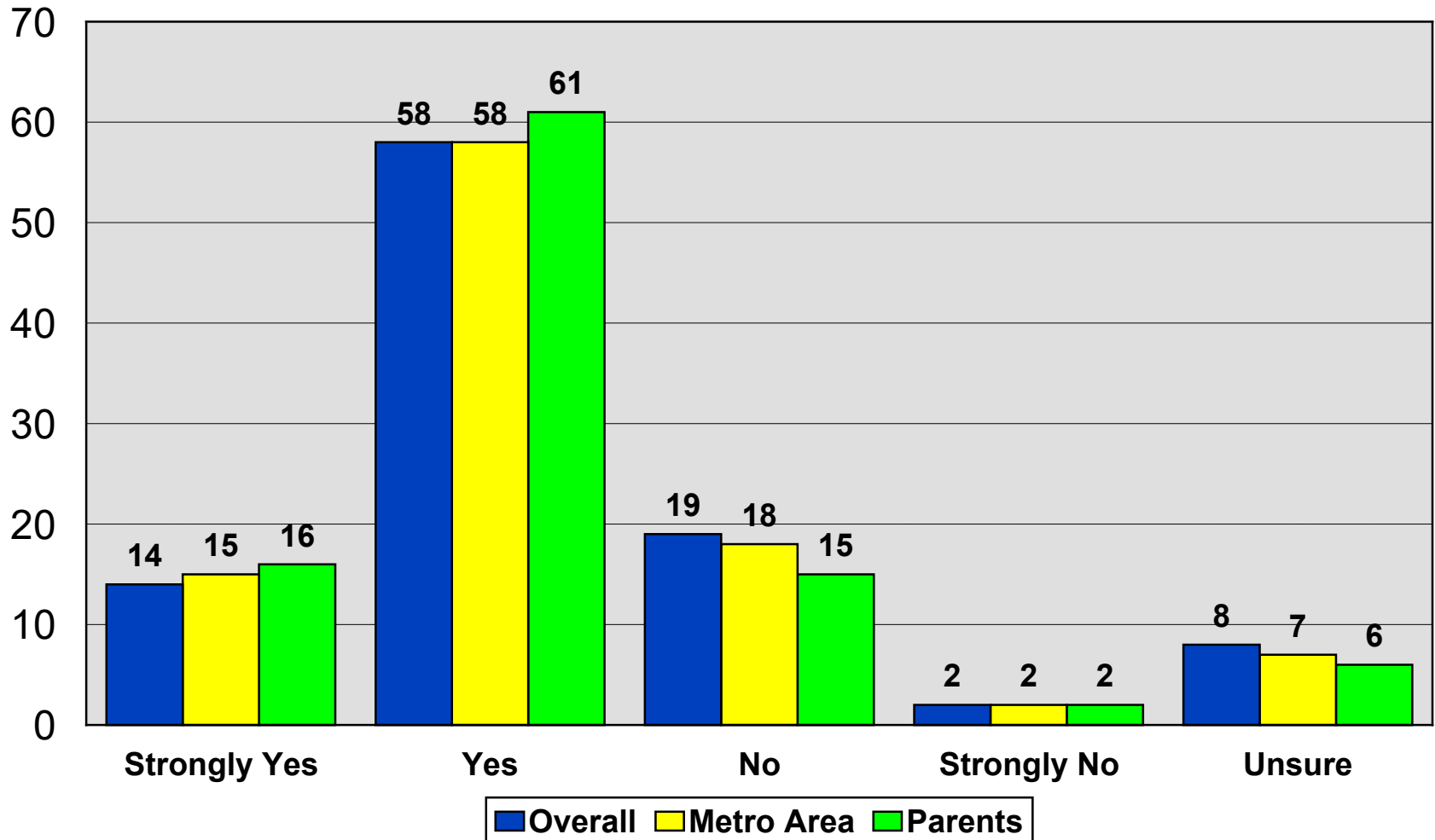
Amount of Say by Parents in Child's Education

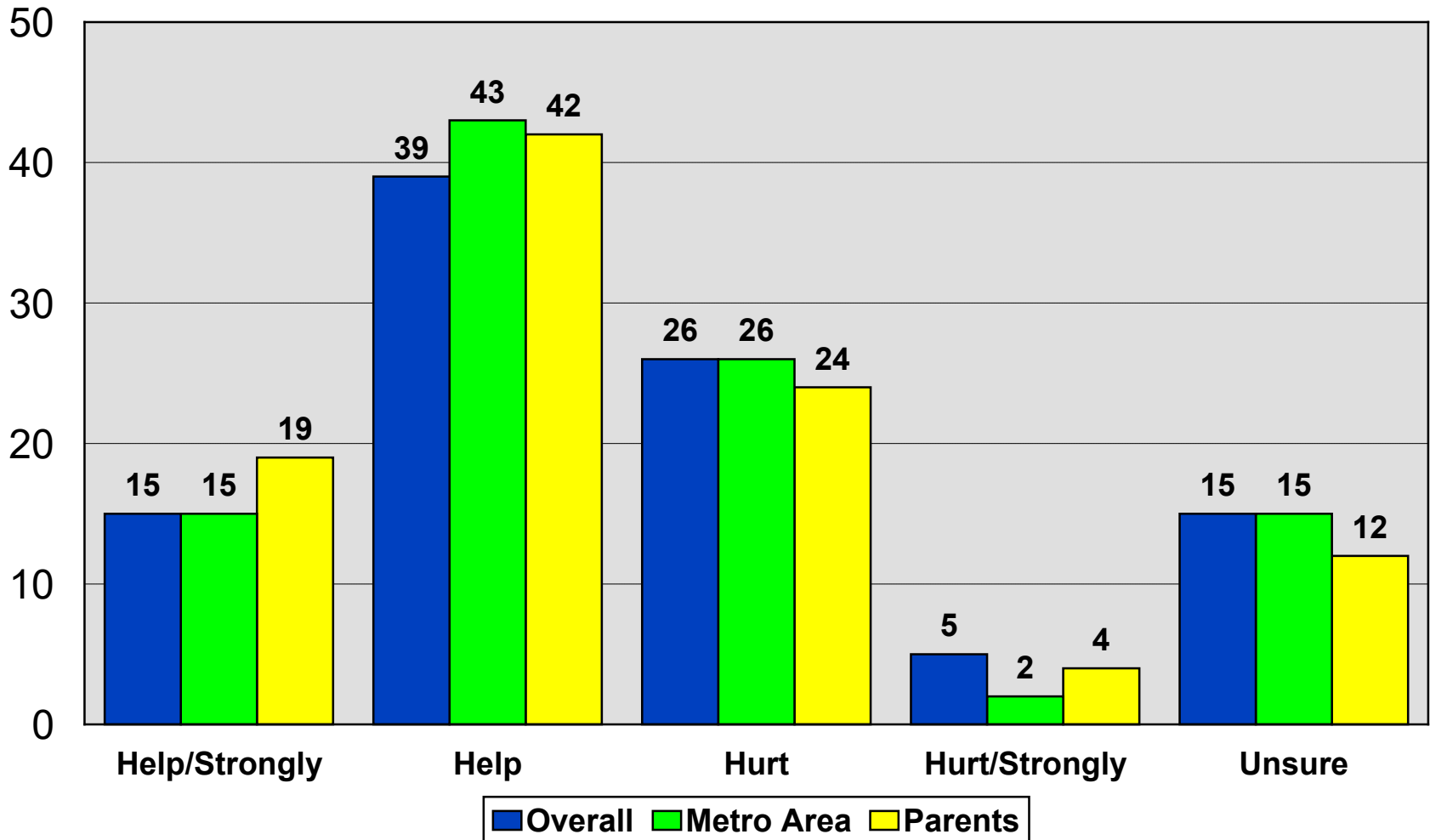

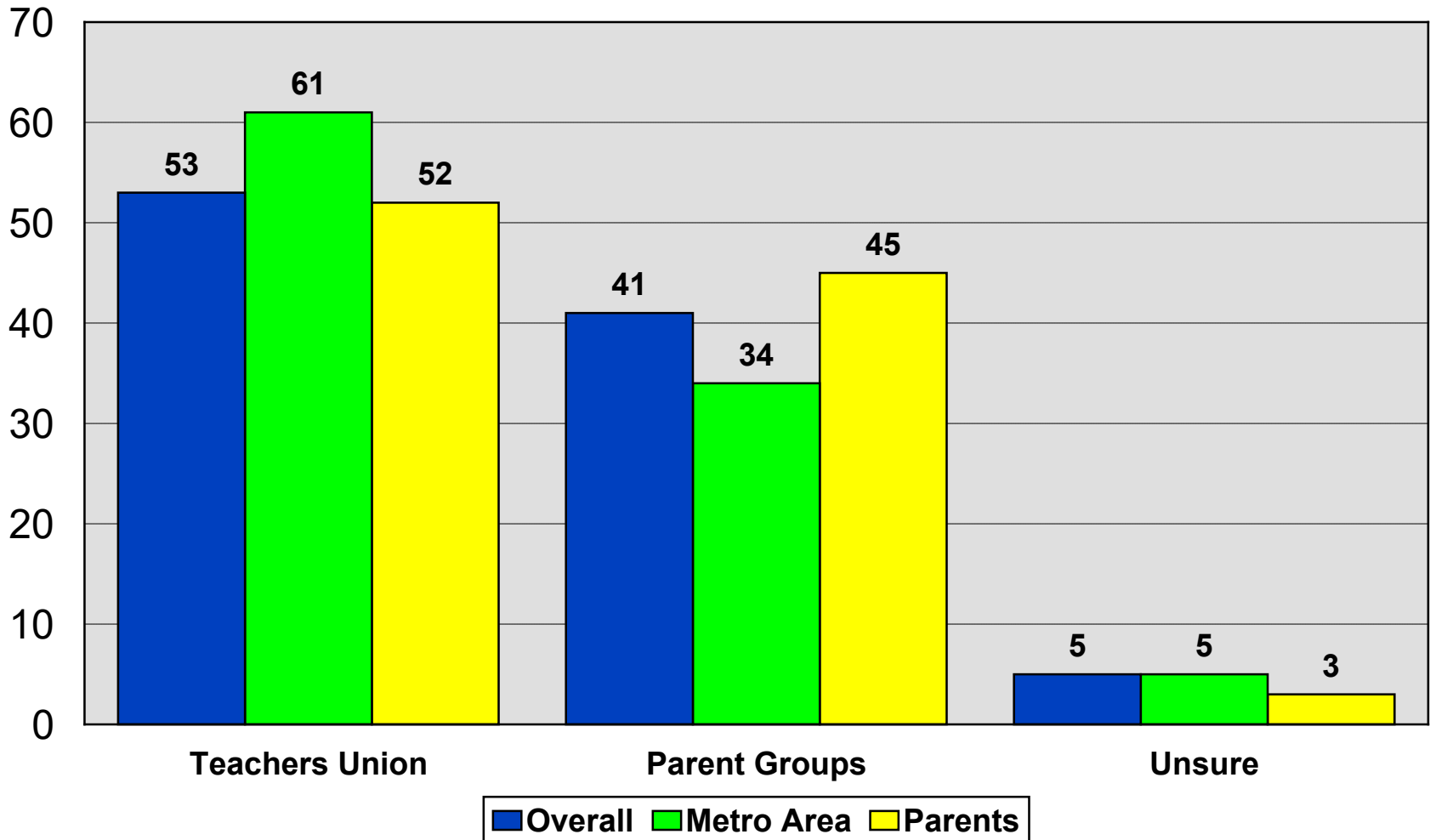

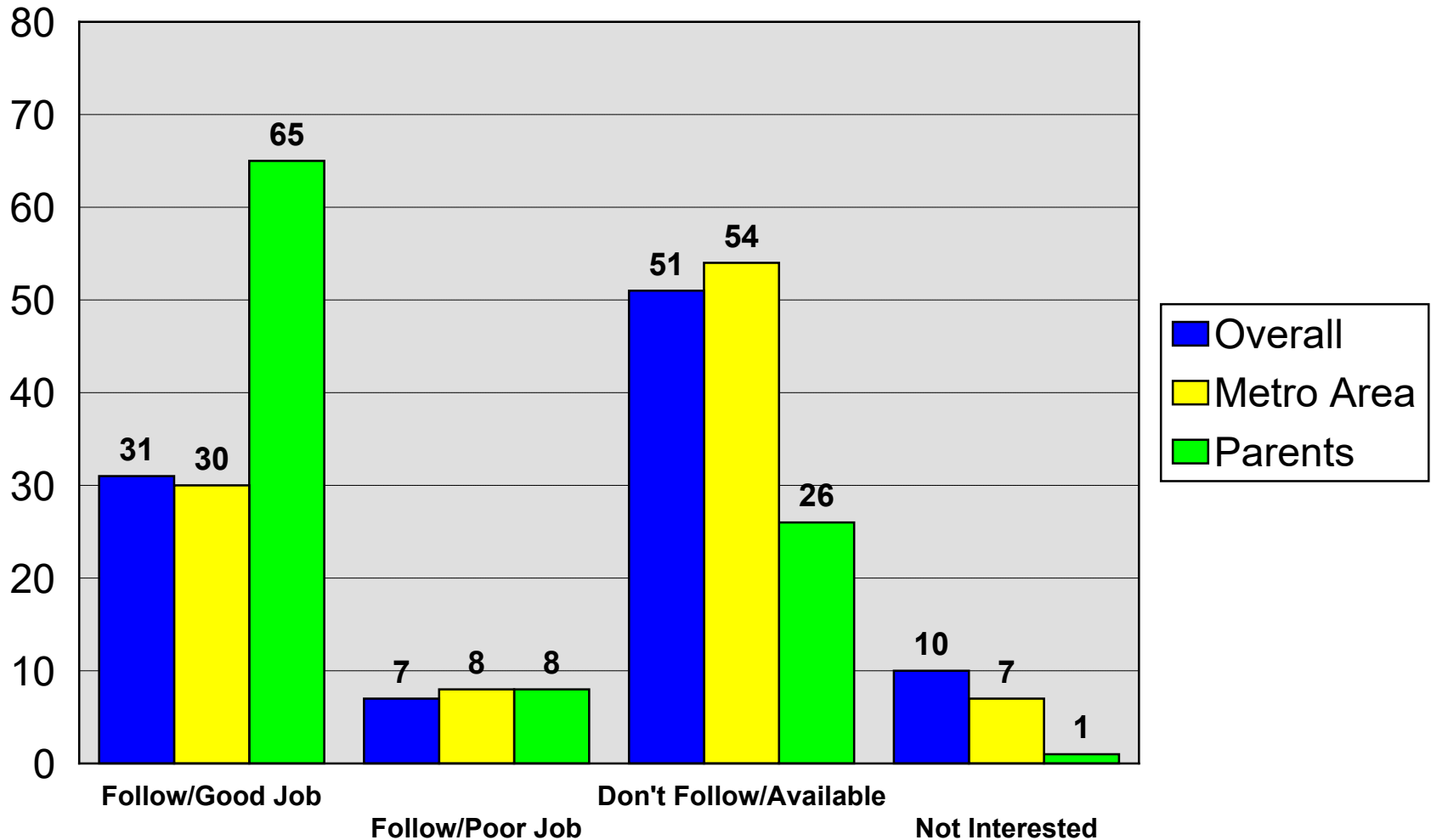

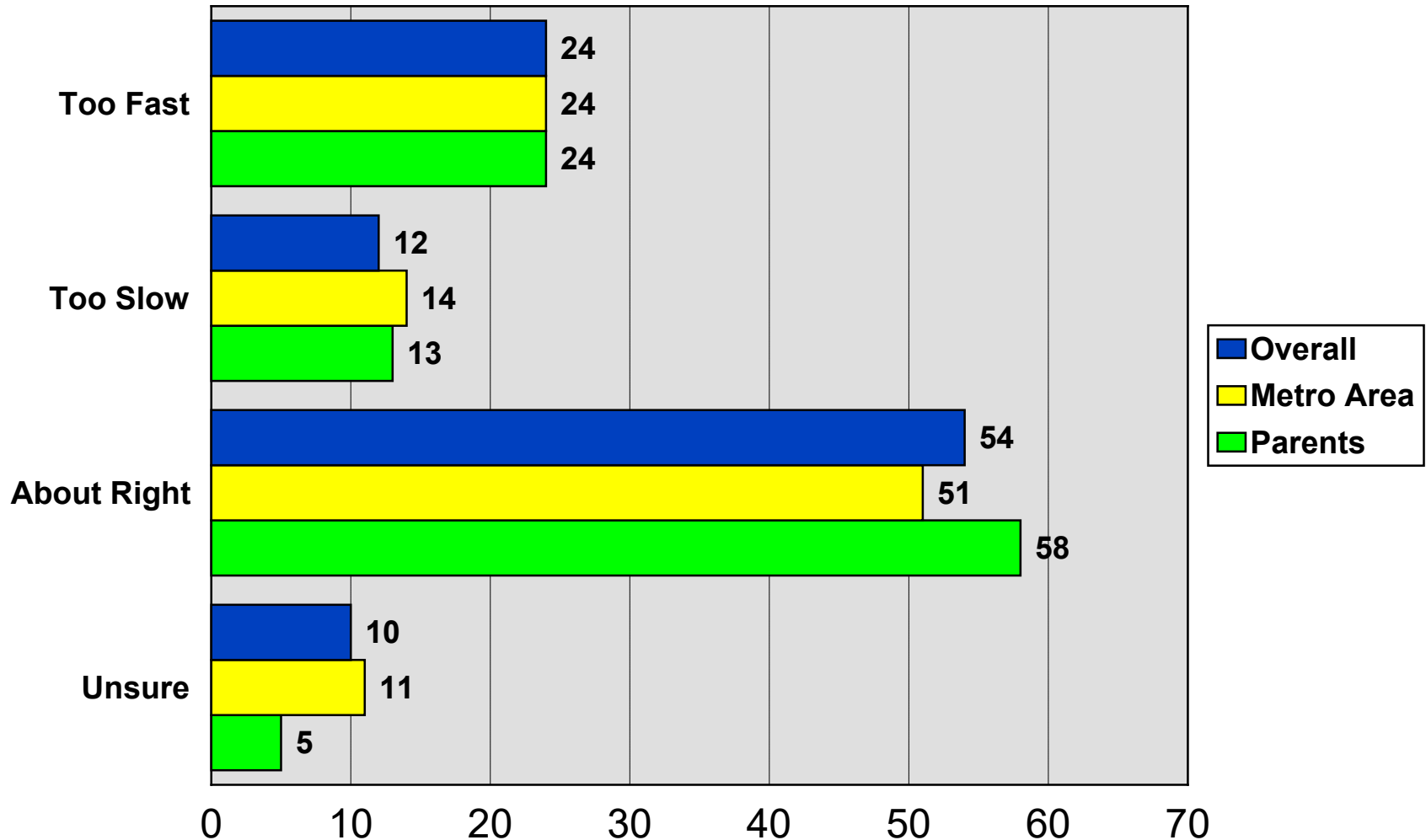

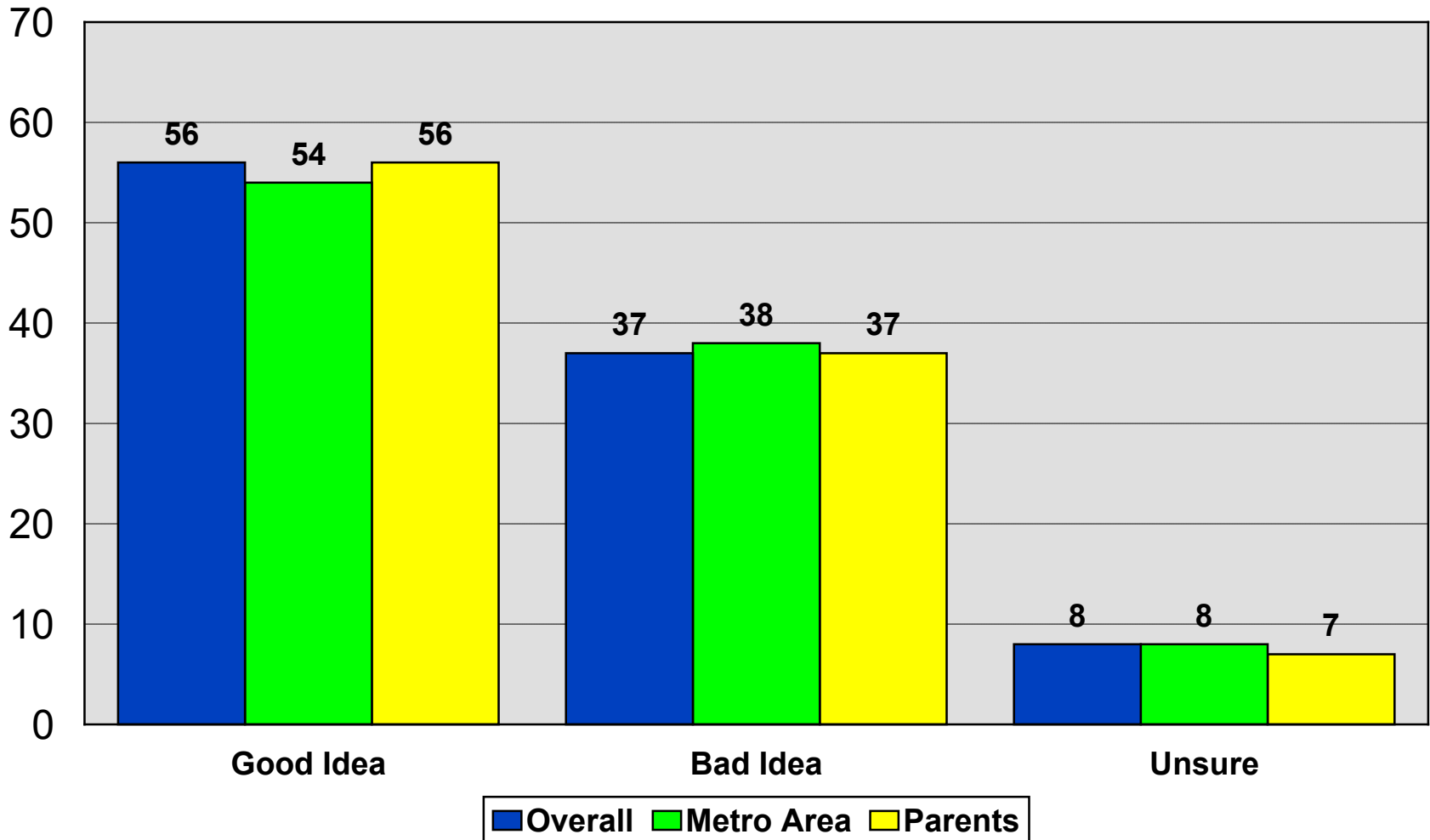

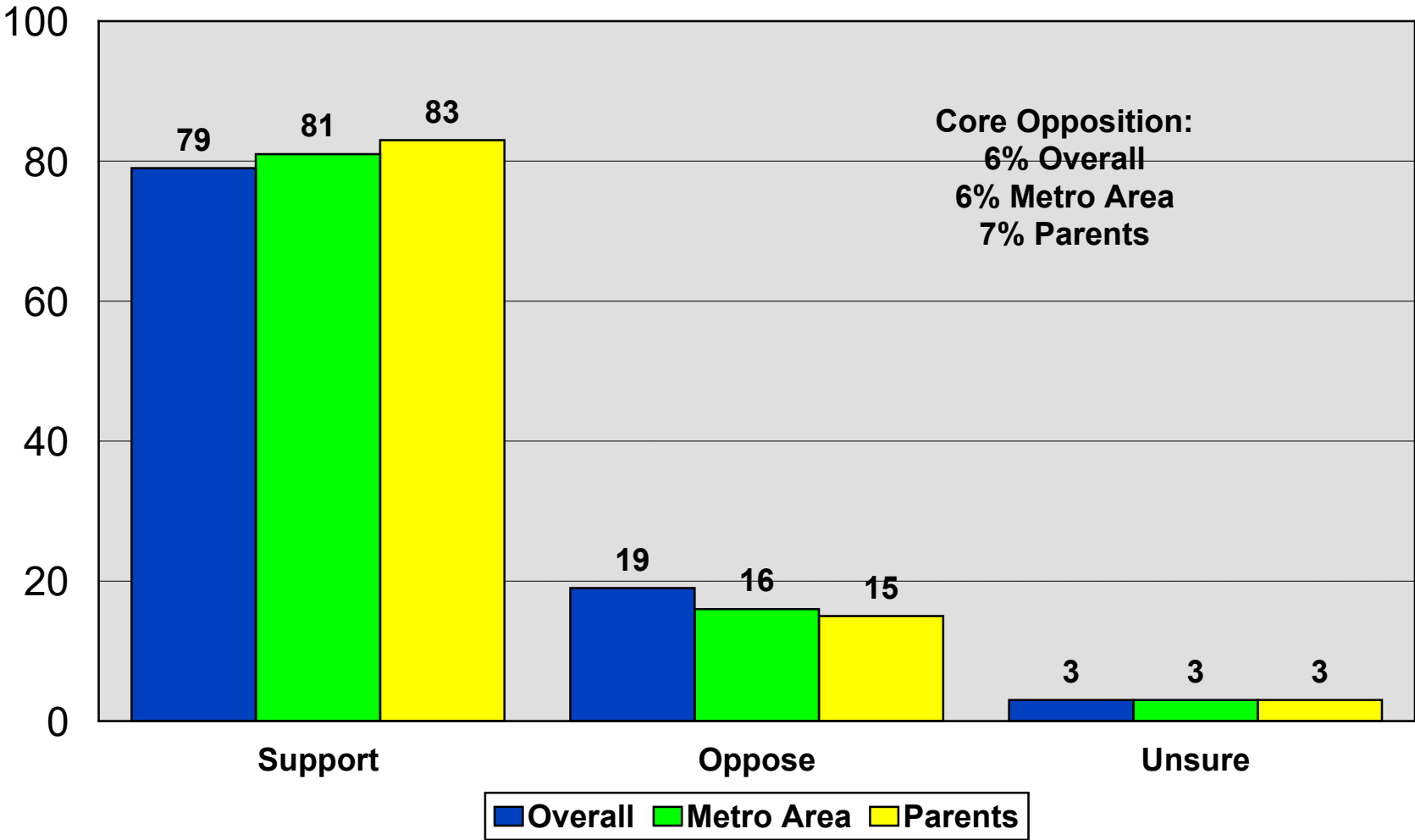

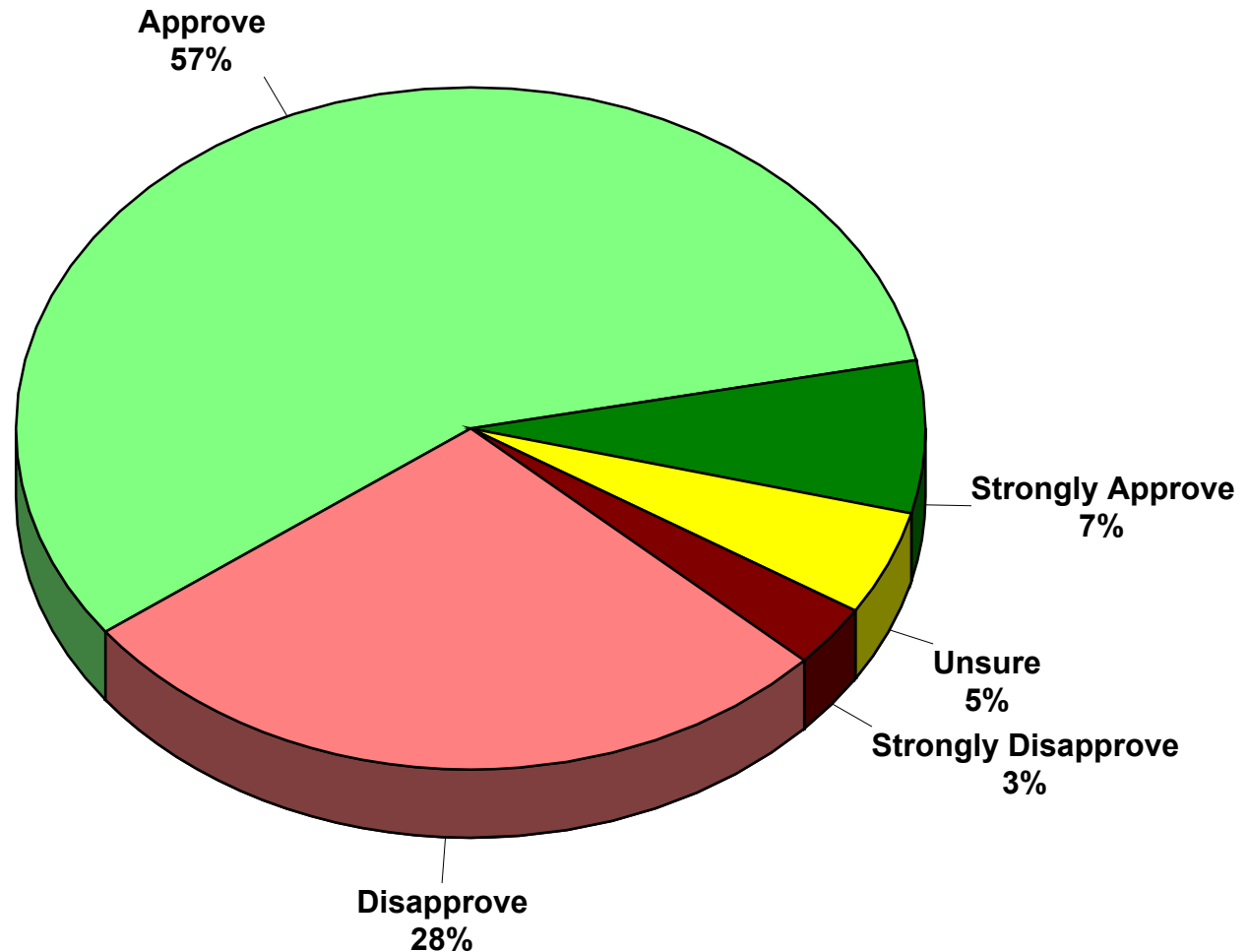

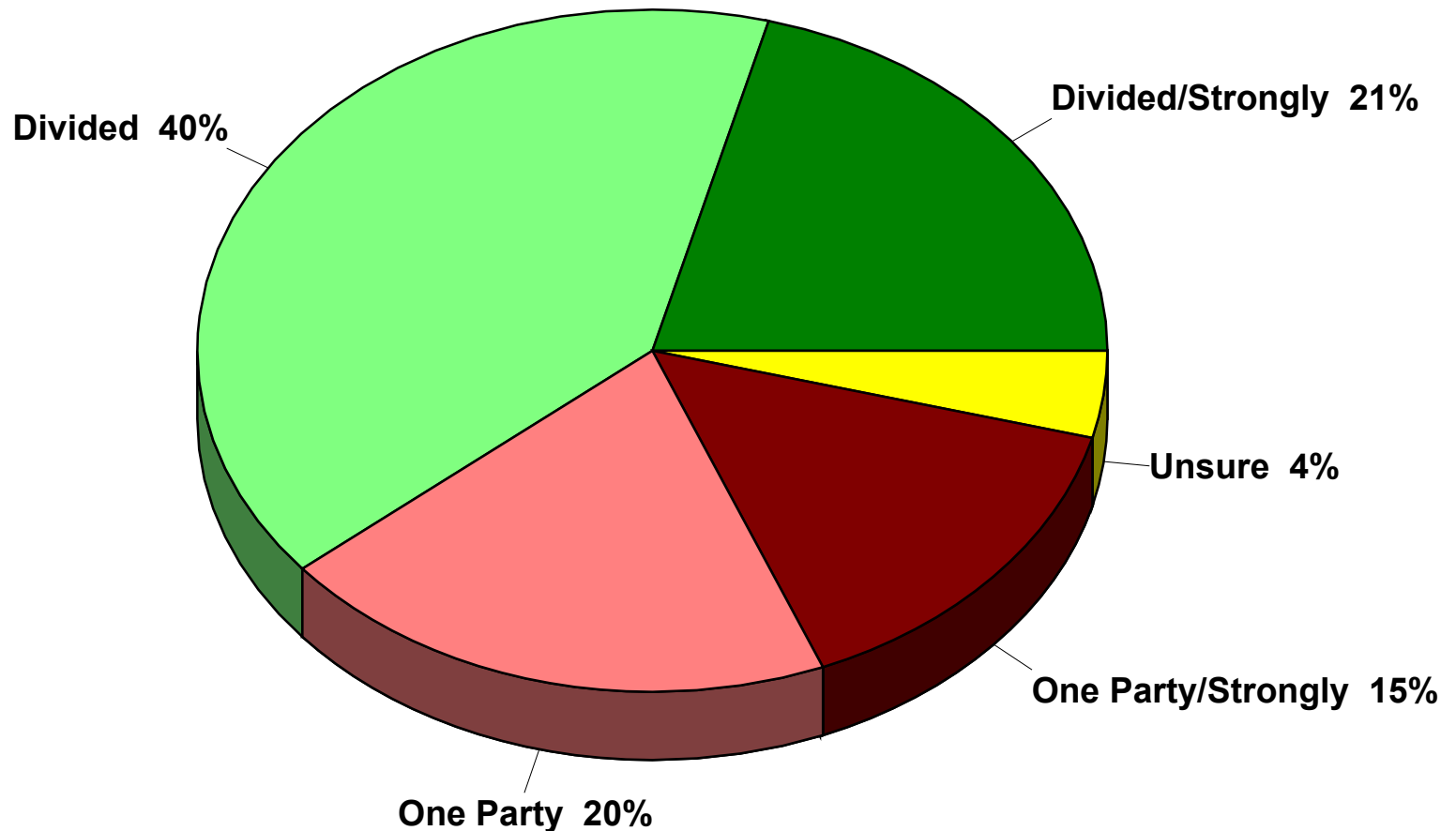
Job Performance of State Legislature

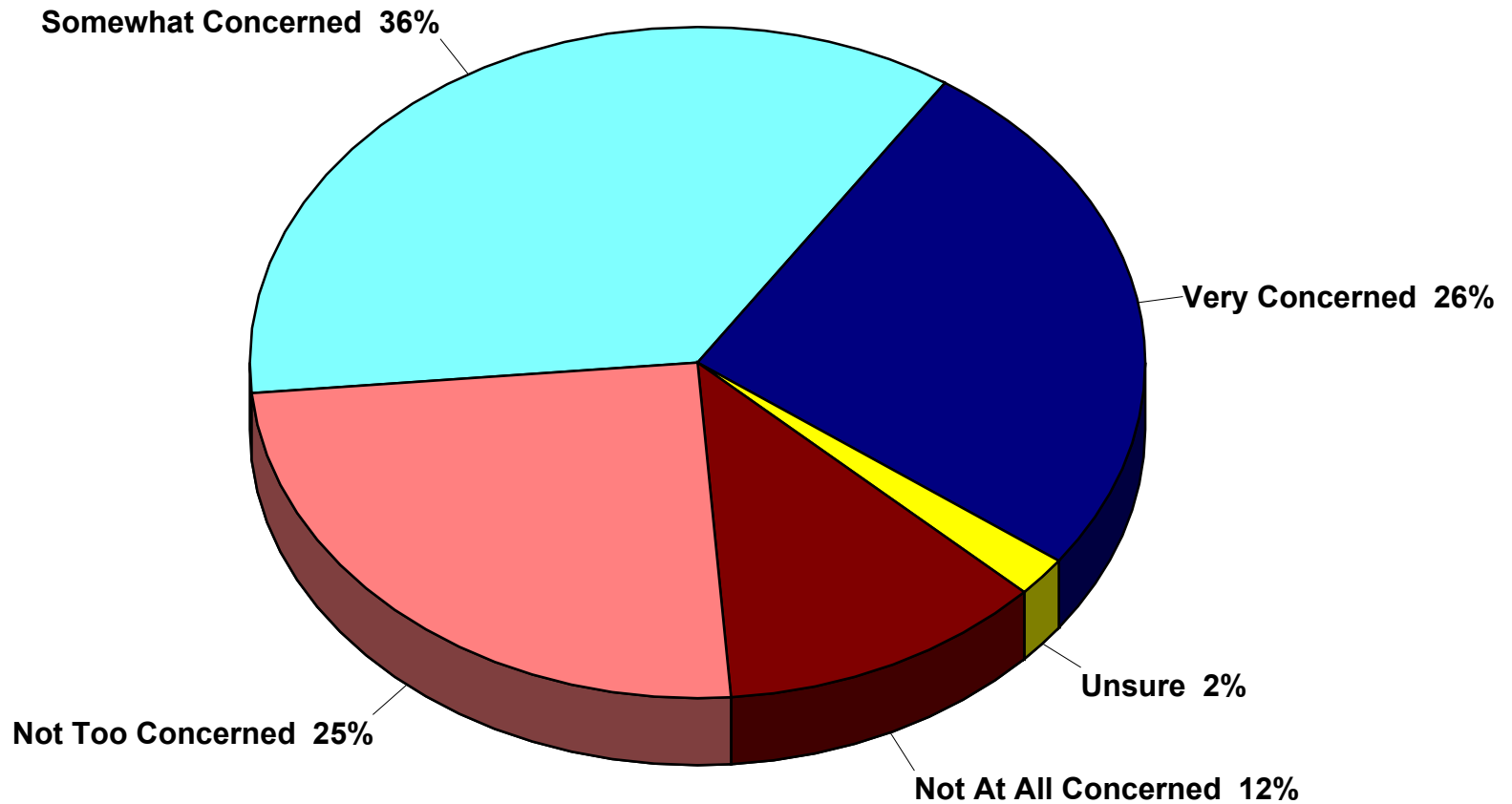

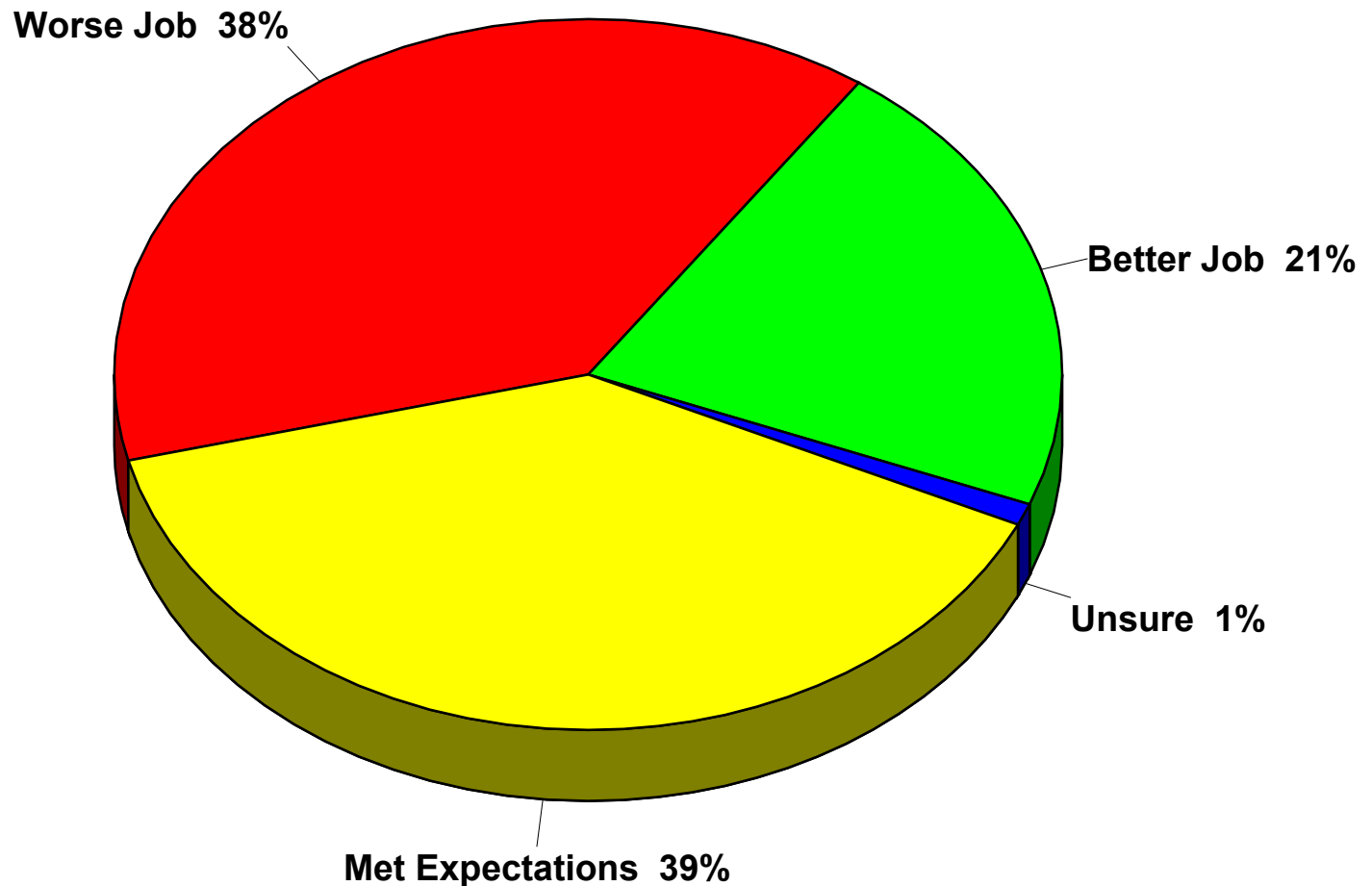

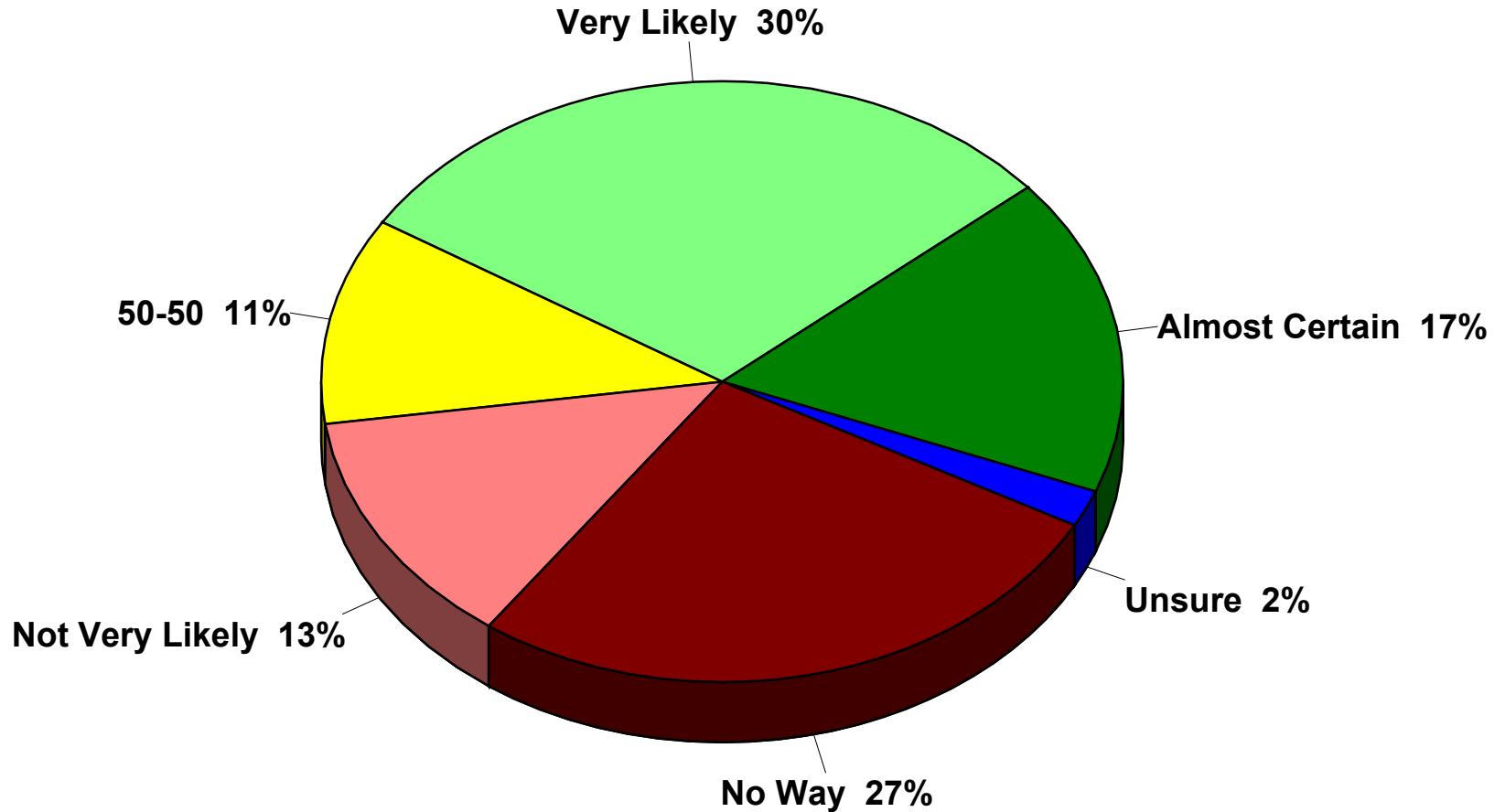
